The goal of this program is to encourage, equip, and assist each participant as he reintegrates into society. At the minimal Residential Program Fee payment of \$210.00* per week plus a \$420.00 Security Deposit, this **year-long program** provides housing with evening programs & classes designed to encourage the residents in their Christ-centered spiritual growth and personal development. **Attendance at each of the activities is required.** It is also required that each resident/participant seeks, finds, and maintains gainful employment so that he will be able to pay for his essential necessities.

***(If at any time Anchor House Outreach needs to raise the cost of the Residential Program Fees, it will be the resident’s responsibility to fulfill that financial obligation.)**
