

## **VVA BOD MEETING**

## 1/13/22 - 1/15/22

The VVA National Board of Directors meeting in Silver Spring, MD was from 1/13/22 to 1/15/22.

Wednesday was a training day for the BOD and State Presidents. President Jack McManus presented a plan to restructure the Tier Meetings and possibly combine some of the Tier to open time frames. He also stated that we need to get back to our grass roots where we had fire in our bellies to assist veterans.

The possibility of more electronic meetings may be in the future since it is now in the VVA constitution. State Council Presidents need to be more involved in VVA issues. They are not a social club, but here to work on the VVA issues.

- 1) Director involvement we are less involved that we were 30/40 years ago. More participation in VVA issues at the State and Chapter levels. We have become complacent.
- 2) Policy/Procedure Update. It was last done in 2020.
- 3) We need to pick our fights on Veteran issues.
