## 11. Report on facilities. Discuss with possible action

- Whitney
  - Discuss with possible action on quote from Salt Ridge Properties for construction of ambulance bay at Whitney Station
    - Bob explained the construction plans. The quote price is \$46,482.50
    - A motion to approve the quote from Salt Ridge Properties for construction of an ambulance bay at the Whitney Station was made by Kevin Bragg, seconded by Jimmy Lehmann and the motion passed unanimously.
  - o Discuss with possible action replacing generator at the Whitney Station.
    - The current generator does not have the load to properly cover the building and helipad. The board agreed to go with the larger generator. The price of \$20,000-\$22,000 does not include labor, concrete pad or switch.
    - A motion to purchase and install a new 45kw generator at the Whitney Station for up to \$22,000 was made by Jimmy Lehmann, seconded by Dan Giles and the motion passed unanimously.
- Itasca Generator issues
  - o Colby will check the switch to make sure it is working properly
- Hillsboro
  - Discuss with possible action construction plans for Hillsboro Station
    - Plans are still being adjusted so no action was taken
  - o Discuss with possible action issuing Request for Proposals for construction.
    - Once plans are finalized, the RFP can be finalized and sent out

## 12. Discuss with possible action placing Automatic Chest Compression device in Air Evac helicopter.

- Review quote and take action on purchase of one device
  - O Quote from My EMS Supply is for \$9,850.00
  - A motion to approve the quote for \$9,850.00 for the Automatic Chest Compression device was made by Bob Stahl, seconded by Kevin Bragg and the motion passed unanimously.
- Take action on Amendment #1 to Air Evac membership agreement regarding use and maintenance of the device.
  - ESD #2 will own the device but Air Evac is responsible for its repair and maintenance. Consumables, such as batteries and pads, are their responsibility as well.
  - A motion to approve the amendment to the Air Evac membership agreement regarding use of the Automatic Chest Compression Device was made by Bob Stahl, seconded by Jimmy Lehmann and the motion passed unanimously.

## 13. Discuss with possible action placing AED units in Sheriff's Department patrol vehicles.

- Review and take action on quote from ZOLL for 20 AED units with discount
  - A motion to approve the quote from ZOLL of \$29,704.60 for 20 AED units was made by Dan Giles, seconded by Kevin Bragg and the motion passed unanimously.
- Review and take action on Interlocal Agreement between ESD #2 and Hill County Sheriff's Department regarding use, maintenance, reporting and training on the devices.
  - O The Commissioners Court approved the agreement between ESD #2 and the county. ESD #2 maintains ownership of the devices, but they are responsible for the repairs and maintenance. Consumables, such as batteries and pads, are their responsibility as well. ESD #2 can also request an occasional report.
  - o The Sheriff's Department is very appreciative of the devices.
  - A motion to approve the Interlocal agreement between ESD #2 and Hill County Sheriff's Department for the purchase of the ZOLL AED units was made by Dan Giles, seconded by Bob Stahl and the motion passed unanimously.

## 14. Approve 2020 Audit and authorize board president to submit to Commissioner's Court

A motion to approve the 2020 Audit and authorize board president to submit to the Commissioner's Court was made by Bob Stahl, seconded by Jimmy Lehmann and the motion passed unanimously.
