## **Paradise Region Gruppe Disclaimer Form**

I and any of my guests voluntarily assume the risks related to exposure to COVID-19 and waive, release and discharge Paradise Region Gruppe and any of its affiliates, directors, officers, agents or volunteers from any and all liability under any theory, whether in negligence or otherwise, for any illness or injury sustained as a result of participating in any event.***

IN CONSIDERATION of being permitted to attend, officiate, observe, work for, or participate in any way in Paradise region Gruppe EVENT(S) EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin:

**1.** HEARBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning or administrative organizations or any affiliated entities thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, sponsors, advertisers, owners, lessors and lessees of premises used to conduct the EVENT(S) premises and event inspectors, surveyors, underwriters, brokers, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and for each of them, their directors, officers, agents and employee, all for the purposes herein referred to as " releasees",FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

**2.** HEREBY AGREES TO IMDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST INCLUDING BODILY INJURY OR PROPERTY DAMAGE that may incur arising out of my presence or participation in the EVENT(S) WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

**3.** HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF RELEASEES OR OTHERWISE.

**4.** Hereby acknowledges that THAT ACTIVITIES OF THE EVENT(S) CAN BE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned also expressly acknowledge that INJURIES RECEIVED MAY BE COMPOUNDEDOR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

**5.** HEREBY agrees that this release and waiver of liability, Assumption of risk and indemnity Agreement EXTENDS TO ALL ACTS OF NEGLIGENCE BY THE RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the province or state in which the Event(s) is/are conducted and if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
