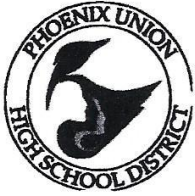

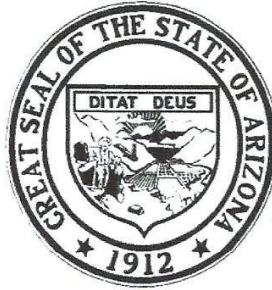

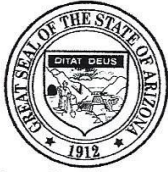

I am pleased to accommodate your request for ticket(s) to the Inauguration of President Barack Obama. Arizona will be well represented.


