WAIVER AND RELEASE:

I, _____ (print name), the undersigned, as the parent or legal guardian of _____ (insert name of minor) (the "Minor Child"), for myself and my heirs, personal representatives and successors in interest, and for and on behalf of my Minor Child, do hereby knowingly and voluntarily release and discharge F. Guy "Rusty" Darby, Jr., each member of his family, High Cotton Class, Inc., a South Carolina non-profit corporation, its officers, directors, and board members, and each of the members of the organizational committee for the Event (hereafter defined), whether such persons are known or unknown to me, (all of the foregoing persons and entities being, collectively, the "Releasees") from and against any and all claims and/or causes of action, arising at law or in equity, which I or my Minor Child may have or claim to have, now or in the future, and whether now known or unknown, as a result of my Minor Child's participation in, or attendance of, the High Cotton Classic Sporting Clay Shoot which is scheduled to occur on August 24, 2024 and August 25, 2024 (the "Event"), and as a result of my Minor Child's participation in any training or other events at the Farm which are related in in way to the Event, on real property owned by F. Guy "Rusty" Darby, Jr. (the "Farm"). I am aware that handling firearms, shooting sporting clays, and attending an event at which firearms are handled and sporting clays and related shooting events are participated in, presents risk; I am further aware that being present on a farm such as the Farm also presents risk. I assume all risks, hazards, and dangers to my Minor Child associated with my Minor Child participating in or attending the Event at the Farm, including in acting as a trapper at the Event, and including any risk, foreseen or unforeseen, of damage to my Minor Child or his property. I agree that I shall be solely responsible for any damage to person or property resulting from my Minor Child's actions while at the Event. I acknowledge and agree that my signing and agreeing to be bound by this instrument, for and on behalf of myself and my Minor Child, is a condition of my Minor Child attending and/or participating in the Event, including as a trapper, and that but for my agreeing to execute and be bound by this instrument, for and on behalf of myself and my Minor Child, my Minor Child would not be allowed to attend and/or participate in the Event.

I represent that I have custodial rights over my Minor Child. I represent that my Minor Child has significant experience in the shooting sports, understands and practices appropriate firearms safety practices, and is physically capable of, and has the requisite experience to, act as a trapper in connection with the Event at sporting clays stations therein. I understand that as a part of the Event my Minor Child may or will (a) act as a trapper in the manner described, (b) shoot sporting clays and related events, and (c) engage in other activities customarily or commonly engaged in for events similar to the Event.

I understand that in attending the Event photographs and/or video footage may be taken of me and/or of My Minor Child. I do hereby irrevocably authorize the Releasees and/or any of them, and those acting at their direction or permission, to copyright, use, and publish, for any art, advertising, marketing, trade or any other lawful purpose whatsoever, any photo or video reproductions of me or my Minor Child taken as a part of the Event, any of which may be disseminated online, by way of any social media platform, or otherwise. I recognize and agree that I shall have no right to inspect or approve any such use in advance or otherwise. I do hereby, on behalf of myself and my Minor Child, waive and release fully (a) the Releasees and those using such content at their direction or permission from any liability associated therewith, and (b) any right or claim that I may (or that my Minor Child may have) have to payment or other compensation associated with any such use.
