Disclaimers

Adopter Agrees To

The undersigned Adopter(s) agree to abide by the terms of adoption listed below:

TRANSFER OF OWNERSHIP: FOR THE LIFE OF THE PUG, THE PUG SHALL NOT BE TRANSFERRED OR SOLD BY BY THE ADOPTER OR MEMBER OF THE THE ADOPTER'S FAMILY, TO ANY OTHER PERSON, TO PRIVATE OR COMMERCIAL CLASSIFIED MARKETPLACE, OR AGENCY, INCLUDING, BUT NOT LIMITED TO, AN ANIMAL CONTROL FACILITY, HUMANE SOCIETY, OR ANY OTHER RESCUE AGENCY, WITHOUT THE EXPRESS APPROVAL OF PUG RESCUE OF FLORIDA & GEORGIA. IF FOR ANY REASON THE ADOPTION IS NOT SATISFACTORY, OR ADOPTER IS NO LONGER ABLE TO CARE FOR THE PUG, PRFG SHALL BE NOTIFIED IMMEDIATELY AND THE PUG SHALL BE RETURNED TO PUG RESCUE OF FLORIDA & GEORGIA (PRFG). IT IS UNDERSTOOD AND AGREED THAT THERE IS NO EXPRESSED OR IMPLIED WARRANTY ASSOCIATED WITH THIS AGREEMENT. PRFG MAKES EVERY EFFORT TO OBTAIN AND SUPPLY ALL KNOWN INFORMATION ABOUT THE PUG. HOWEVER, PRFG IS AN ALL-VOLUNTEER ORGANIZATION, AND THIS IS A RESCUE AGREEMENT, NOT A RETAIL/PET STORE AGREEMENT.

RETURN POLICY: Every effort has been made to make a good match; however:

IF PUG IS RETURNED TO PRFG, WITHIN 15 DAYS of the execution of this Agreement, and adopter has the option of donating the adoption fee to PRFG or requesting up to a 100% refund. If adopter requests a refund, PRFG will refund Adopter up to 100% of the adoption fee less a \$50 Handling Fee.

IF PUG IS RETURNED AFTER THE 15TH DAY BUT PRIOR TO THE 30TH DAY from the execution of this document, adopter has the option of donating the adoption fee to PRFG or requesting a up to a 50% refund. If the adopter requests a refund, PRFG will refund Adopter up to 50% of the adoption fee.

IF PUG IS RETURNED AFTER THE 30TH DAY from the execution of this document, Adopter forfeits 100% of the Adoption Fee. However, as stated in Paragraph 1 above, FOR THE LIFE OF THE PUG, in the event the adopter can not keep the pug, IT MUST BE RETURNED TO PRFG.

NOTE: IN ORDER TO BE ELIGIBLE TO RECEIVE EITHER OF THE REFUNDS STATED ABOVE, THE ADOPTER MUST DRIVE THE PUG BACK TO THE AREA FROM WHICH IT WAS ADOPTED. IF ADOPTER IS UNABLE OR UNWILLING TO DRIVE THE PUG BACK TO ITS FOSTER HOME, PRFG WILL PICK UP THE PUG, BUT AT THAT POINT THE ADOPTER WILL FORFEIT 100% OF THE ADOPTION FEE.

PURPOSE OF OWNERSHIP: The pug shall be a companion animal and a house pet. The pug will not be used for medical or experimental purposes whatsoever.

HEALTH: The pug shall be placed on an inoculation program as prescribed by a licensed veterinarian in order to assure and maintain the health of the pug. The pug shall receive a rabies vaccination and be licensed in accordance with state and local ordinances. The pug **MUST be tested for heartworms annually, and heartworm preventative shall be administered consistently as prescribed by a veterinarian.**

CONTROL: Because of the body structure of the pug, the Adopter agrees to only use a harness and leash (never a collar). The pug shall not be allowed to run loose in an unfenced area except in controlled events or dog parks. The pug shall not be kept chained or tied, or left outside in the Florida heat, all night or in inclement weather. THE ADOPTER SHALL NOTIFY PRFG IMMEDIATELY IN THE EVENT THE DOG IS LOST OR STOLEN.

CARE: The Adopter accepts full responsibility for maintaining a reasonable level of care of the pug, including food, water, grooming, sanitation, exercise, and safety. The Adopter accepts full responsibility for all medical expenses for the pug upon execution of this Adoption Agreement & Release Contract.

EXPENSES AND LIABILITIES: The Adopter agrees and understands that PRFG will not be responsible for any medical care or costs thereof once the Pug is in the possession of the adopter. I understand that PRFG and its officers cannot be held responsible for the conduct, behavior, or disposition of this Pug after placement. The Adopter agrees to indemnify and hold harmless PRFG and its officers, directors, representatives, or agents for all manner of actions and causes of actions, suits, debts, dues, accounts, bonds, covenants, contracts, agreements, judgments, claims, and demands whatsoever arising out of the placement of this animal. Unconfirmed and unverified information has been voluntarily provided to PRFG, but PRFG has undertaken no investigation with regard to the history of physical conditions of Pug(s) and makes no warranty or guarantee, expressed or implied, with regard to the physical condition of the pug(s), their background, or their suitability or compatibility.

AIRLINE RESTRICTIONS: The adopter agrees and understands that the pug may never be checked as luggage in the plane's hold. The adopter also agrees and understands that, if the pug is large enough to fit in the cabin, it cannot fly on flights lasting more than 5 hours.

MICROCHIPPING: Pug is microchipped, and the microchip has been registered to Pug Rescue of Florida & Georgia through 24PetWatch. Pug Rescue of Florida & Georgia will remain the "rescue of record" for the life of the pug. After the adoption is complete, PRFG will update the pug's profile with the adopter's contact information. 24PetWatch will then contact the adopter and provide the option to create a free account to further administer/maintain the pug's primary contact information.

FAILURE TO COMPLY WITH THE TERMS OF THIS AGREEMENT will result in forfeiture of the consideration paid by the Adopter and shall allow PRFG to reclaim the pug. Furthermore, the Adopter understands that PRFG may examine and make inquiries about the pug at any time and, if not satisfied with its condition or the conditions in which it is kept, PRFG shall reclaim the pug immediately.

MEDICAL SUMMARY: PRFG makes every effort to provide each adopter with complete medical information for each adopted pug. However, to ensure that all medical information on your new pug is received by your vet, we do allow adopters' vets to call and obtain the medical records from PRFG rescue vet(s) -- contact information for PRFG vets is available by contacting PRFG at pugrescueofflorida@gmail.com.
