From the Chairman's Desk...



I don't know about you, but I've had enough winter for this year! With that being said, let's talk about the Lake Management Plan for Pickerel Lake and Crane Lake. If you will recall, or if you missed the last annual meeting, we discussed the Lake Management Plan and indicated how this lengthy and costly plan was now being required by the Wisconsin Department of Natural Resources. Without a completed plan, our lake district would no longer be eligible for an aquatic plant harvesting permit or any future State of Wisconsin lake grants effective immediately.

At the 12/10/08 Commissioner's meeting, the board voted to pursue a grant to help find the cost of developing a Lake Management Plan. They also voted in favor of hiring the consulting firm of Onterra, LLC from DePere, WI to submit the application and help

Management Plan. Onterra agreed to only be paid for writing the grant if the project was funded. The grant-writing fee was included in the grant application.

Onterra, LLC has projected the total cost of this project to be \$31,727. If funded, the WDNR grant would cover 75% of the cost leaving the Lake District with an in-kind local match of roughly \$3,739. Please keep in mind that this project will only happen if we are fortunate enough to be awarded the planning grant. As you can expect, there is a lot of competition for these grant dollars. As soon as the state awards the grants, we will let you know if our application has been successful.

You should know that the Lake Management Plan is going to require several meetings and many hours of your commissioner's time as well as including those who own property in the Lake District as well as other lake users. During the planning process, we will be required to set up several committees which will address certain elements of the plan. In order to ensure success we will need everyone's support and input in this process.

I would like to close by saying that while we know the Lake Management Planning process is a requirement; let's not look at it as just another state mandate but look at this as an opportunity for us to create the best management plan possible for our two lakes. The more we do in planning for the future, the better success we will have in ensuring the health of Pickerel and Crane lakes for future generations to enjoy.

Aeration News



Fish Stocking Update

Mr. Mike Vogelsand, our Forest Country WDNR Fisheries contact, has informed us that fish stocking should begin once again in both Pickerel Lake and Crane Lake in 2009.

In anticipation of having a fresh batch of fish stock Dan Voster's, our DNR Lake Representative, has asked us to remember that no lake as an infinite number of fish. Studies have shown the larger fish inhabit the choice spawning sites. When the larger fish are depleted, the smaller fish move in. Often times, this is a genetically stunted new population that will be unable to produce the quality fish we all dream of catching. This study shows that by letting the healthy, larger sized fish spawn and taking fewer fish produce a fishery of larger and much nicer sized fish. He is asking that when you make that wonderful catch, please be conservative as to what you keep. Take what you can eat, but let a few grow for another day!



Did You Know?

Did you know that the DNR has been actively trying to restore a migratory whooping crane population in Wisconsin? Prior to 1999 only one migratory population of whooping cranes existed in the wild. Today, there are 85 whooping cranes in our Eastern Migratory Population with an additional 25-30 birds planned on being introduced The goal is to have a self-sustaining migratory population of 100-120 individual birds and 25-30 breeding pairs. Provide the date, time, exact location, bird behavior, description (including if the bird is banded), and a photo if available.


