### From the Chairman's Desk...

This past spring I spoke about the Pickerel Creek Dam with regards to the WI Department of Resources (WDNR) ordering the Town of Ainsworth to lower the water levels in Pickerel, Crane, and Rolling Stone Lakes so that more water could be sent downstream. I spoke about the meeting our Lake District had with the WDNR where we were told that our only remedy for appealing their decision and possibly restoring our lakes to their original levels was to file a petition signed by 100% of all lakefront property owners on all three lakes.

In May I was advised by the WDNR that there seemed to be some confusion about this so-called "petition". It appears that now it's really not a "petition" at all; it's an easement, and must be signed by every single lakefront property owner. I requested a sample of this easement, and it came as no surprise to me that it was so one-sided and confusing that I myself would never sign and therefore, could never even consider asking you to sign.

I forwarded this *easement* to an attorney who agreed that he wouldn't sign it either and

couldn't imagine anyone else signing.

Furthermore, in June, WDNR employee Terry Cummings advised us by email that even if 100% of all of the lakefront property owners did sign this *easement* the WDNR still has the authority to lower the lake levels to whatever is required to maintain the flow downstream.

Therefore, unless someone has a better solution to this problem I will consider it "dead in the water" or more accurately "dead for the lack of water".

Luckily we have received several inches of rain this summer so the lakes are not yet suffering.

Finally, as most of you know we had a tornado hit our area in late June. We suffered some structural damage and many of the town roads were impassable due to downed trees and power lines.

As Nashville Town Chairman, I would like everyone to know that immediately after the storm hit, the town employees

and volunteers worked well into the night to clear all of the roads of debris so that they would be open for emergency vehicles.

At first daylight numerous area volunteers and fire and rescue squads were organized to complete a "search and rescue". These EMT's, Firefighter's and volunteers checked every residence in the affected area to make sure everyone was safe and noted any structural damage so the town could notify our seasonal residents of damage to their property. We are very fortunate to have such a great group of individuals in our community and surrounding area. Without their assistance the town would not have been able to serve the community as effectively as we did in this emergency situation. Thank you from all of us.

## Lake Management Plan Update

This past summer the Lake Residents Committee consisting of people from both lakes met with Tim Hoyman who is creating our Lake Management Plan. The first meeting provided the committee with an extensive overview on the health of our lakes. On average, the water quality analysis of both lakes is good with the lakes being moderately productive to productive. According to Onterra, our overall watershed is in great condition. In regards to the Lakes Fishery, we have Black Crappie, Bluegill, and Pumpkinseed in the sunfish family, Brown Bullhead, Largemouth Bass, Northern Pickerel, Walleye, and Yellow Perch with regular stockings of Walleye. Obviously, the greatest concern is with the invasive weed Eurasian water milfoil. Options were placed before the committee to consider what plan of action to take. The committee agreed with Mr. Hoyman that we should wait one year to review other lakes' success with chemical treatment. When all the data is in, we will bring the treatment plan options before the Lake District at one of our meetings for your approval. There are grants available from the state to cover half the cost. While important, this is just one component of the Lake Management Plan. Other areas of concern that will be met are water levels, communication between Crane and Pickerel Lake, and bass regulations. Please make every attempt to attend our annual meetings.

# Important Lake Reminders

As we close out the summer, it is important to remember that there is a 100 ft. no wake zone ordinance. This is a statewide ordinance that will make it safer for those swimming or fishing near the shoreline. Along with the safety issue, boats often churn up sediment, chop vegetation, decrease water quality, increase shoreline erosion, and potentially spread invasive weeds. Sawyer Lake recently experienced a tragic accident this summer as a man on a jet ski attempted to splash his relatives on the dock and inadvertently seriously injured his niece who was his passenger. Please, don't ignore this rule thinking that you are doing no harm.

It's hard to believe that the lake will soon be covered with ice. As the ice fishermen return to the lake, we ask that you remember that any garbage you leave behind will eventually end up sinking into the lake in the spring. Shoreline residents can attest to seeing items such as tarps left behind. Often it is too late for anyone to safely go out on the ice to remove such items. Once these items sink, there is no way to reverse the damage caused to our lake and fish.

We ask you to use the lake wisely. It is a place of incredible beauty that provides peace and recreation to all of us. Let's be wise with how we use it.
