Wisconsin DNR Fisheries Update – Greg Matzke

By now most of you should be aware that there has been a pretty intensive “bio-manipulation project” on Pickerel and Crane Lakes going back to 2012. This has truly been a joint effort between your Lake District, WDNR, and the Mole Lake Chippewa Community. The goal of this project has always been to re-establish a quality walleye fishery in the two lakes, with the ultimate success being the return of a naturally reproducing walleye population within the lakes. Natural reproduction has not occurred in these lakes in a very long time, and to be honest, we are not sure that regaining natural reproduction can be attained, but we sure have been trying hard.

I like to think of this project as having 4 main parts. The first of which, establishing a better understanding of the fishery, took place in 2012. We measured and assessed the main fish communities of the two lakes, those being bass and pan fish species. This information will be very valuable going forward as we gained strong “baseline” data that will allow us to track changes within the fishery. The 2nd phase was to do everything in our power to increase the abundance of adult walleye in the system. We focused our efforts at stocking large fingerling walleye, rather than the small fingerling walleye that have been stocked by WDNR in the past, and showed little success. Since 2012, your Lake District, WDNR, and the Mole Lake Community have stocked a total of 47,108 of these larger walleye into the two lakes, with Crane getting the majority of the stocking (55%). During the 2012 fish surveys, we documented an incredibly high abundance of large bullhead in the lakes. This is what created the 3rd phase of the project, a plan to reduce the abundance of bullhead to increase the survival of stocked walleye and make room for the increased abundance of walleye. So far we have put in 2 years of directed effort at removing bullheads equating to a total of 20,638 fish weighing approximately 13,040 pounds. The 4th phase of the project is one that we hope to accomplish this year, to assess the success of the project, provide a survival rate of juvenile walleye to adulthood, and assess whether the lakes still possess the ability to naturally produce walleye.

The start of what we consider a “comprehensive survey” of Pickerel and Crane Lakes will be immediately after ice-out. Nets will be set around both lakes targeting spawning walleye and northern pike (during this survey we will also assess yellow perch and black crappie populations). During spring netting we will give adult game fish an identifiable mark, which will allow us to conduct another survey about a week after ice-out with our electrofishing boat to gather another sample of both species and use the ratio of new fish to recaptured fish (those captured during the netting survey) to estimate the abundance of walleye and northern pike. A few weeks after our walleye and northern pike assessment, we will again set a large number of nets to conduct yet another bullhead removal on the lakes, and electrofishing surveys will take place to assess the largemouth bass population. Nets will again be deployed in late May/early June to assess summer spawning pan fish, and the survey will eventually culminate with a fall electrofishing survey to assess the level of natural reproduction of all game fish.

So you will be seeing our nets, electrofishing boat, and our crew on the lake quite a bit this year. If you see us feel free to stop by to get a better understanding of what we are doing, and we can likely give you a quick update as to how the fishery is looking. I ask that you pay attention for buoys on the lake, which will mark the locations of our nets (which run from the buoy to the shoreline). We will be down there enough that you will likely get sick of us by the end of the survey, but just remember the nets are only in the lakes temporarily and they will provide valuable insight as to the success of this project.

Dec 31, 2016 - Installed barriers, started both blowers

Feb 16 2017 – due to warmth fence was repositioned

Apr 2, 2017 - removed all the stacks from the lake.

Aeration system Boss 'Hot Dog' advises that this was the worst year that he has ever had due to the warm winter and Mother Nature. This unusual winter kept him and his volunteers extremely busy maintaining the system and the safety fence.

Completed and Upcoming Projects

Cleanup activities commenced in October on the stream coming into Crane Lake from the watershed south of Saint John's Lake. Debris was removed on the stretch between Doemel Lane and the lake. Results were immediate and is now provided fresh water confirmed by a lack of freeze up at the entrance to the lake.

At spring meeting Brad Kupfer will be conveying fish habitat recommendations provided by the WI DNR.
