The topic of the class was *Clean Waters: Our Mission, Our Legacy*.

I came away with some data we all should consider. While we all have fire and property damage insurance on our lake homes, what kind of insurance do we have on our lakes? Let's think about that. If you have insurance on your property and it burns down, you are covered for the value. If the lake becomes degraded in some way and it has lost its value, your property and investment take a hit. I have asked Margie, our newsletter editor, to include some facts about how clean water affects the value of your lake property. I think you will find it very interesting.

Just where am I going with this? Well, we all pay a pretty penny to have our lake property insured. Now let's compare this amount to what we pay to have a Lake District that works for the protection and rehabilitation of our lakes. In my opinion that's a good value! How can we do this job? Well, it's because of our great volunteers. I have recently spoken with the chairman from another lake district and a president of one of Wisconsin's oldest lake associations. Sadly, they are considering dissolving the organizations due to a lack of volunteers. We need the younger folks to step up! I have said this before and yet very few answer the call. Lake Management Plan (LMP)

White Water Associates, Inc. has begun implementation of the Pickerel/Crane Lake Management Plan. Dean Premo, President of White Water Associates, Inc. has sent us the following update:

"As you are aware, this summer we are in a data gathering mode for Pickerel and Crane Lakes. By the time of your annual meeting, the major tasks completed will be the (1) Shoreland/Shallow Water Assessments, (2) Point-Intercept Aquatic Plant Surveys, (3) Aquatic Invasive Species Surveys, and (4) Water quality sampling (including dissolved oxygen and temperature profiles). These are data intensive undertakings (especially the shoreland/shallow water assessments and the aquatic plant surveys) with large data sets that require checking, data management, and analysis. In the case of the aquatic plant surveys, voucher specimens for each plant species will be collected, pressed and dried, labeled and mounted, and shipped to UW Stevens Point for verification of our identifications. This is a several month process after which we can input the data into a dedicated spreadsheet and analyze the output for comparison to the previous point-intercept plant survey and preparation of an aquatic plant management plan."

"Clean Waters: Our Mission, Our Legacy"

Chairman Chuck Sleeter attended the annual meeting of Northern Wisconsin Lake Group leaders and members from six counties on June 12th. This event organized by the Oneida County Lakes and Rivers Assn., along with Vilas County Lakes and Rivers Assn., focused on ways to encourage natural shorelines and cleaner waters.

According to Chuck, one of the most interesting presentations at the event summarized studies linking lake quality to Northwoods' economies and property values. A recent study by Dr. Thomas Kemp of UW Eau Claire concluded that the value of home prices increases as lake water clarity increases. This study estimated the residential property value gains associated with improvement in water clarity on 60 northern Wisconsin lakes in Oneida and Vilas Counties. Below are some results from Dr. Kemp's 2018 report.*

- Depending upon the lake, an improvement in water clarity by about 3' would increase average home sale values by \$8,000 to \$30,000.
 An increase in water clarity of approximately 6' could increase home prices by as much as \$47,000.
- On extremely clear lakes an increase in water clarity would not add much more value.
 However on a lake with limited clarity, improving water quality could have a significant impact on sales price.
- Conversely if water clarity diminishes, the sales value will decline, but more dramatically, due to the logarithmic nature of the relationship.
- Depending upon the lake, a decrease in water clarity of 3' could decrease average home sale values by up to \$45,000. A decrease in water clarity of approximately 6' could decrease home prices by as much as \$64,000.
