

# Pickerel/Crane Lake P&R District Fall Newsletter, 2022

## From the Chairman's Desk - Chuck Sleeter

Hello everyone,

I would like to take this opportunity to point out a few things that we sometimes overlook.

First, early this summer we were advised by a number of folks that the Crane Lake boat landing had several very deep holes and the landing was not usable. Contact was made with the Town of Nashville, who then attempted to fix the deep holes at the landing. We found that the attempt to repair the landing had failed and the district proceeded to make more extensive repairs. The folks on Crane Lake and the Lake District, with the aid of Dan Welhouse, Steve Bailey, and Chuck Jackson dug out the existing frost pockets with our trucks and filled each pocket with stone. These areas were then covered with crushed stone and a special road gravel mix. A special thanks to Dan Welhouse for a great job using his equipment to level the gravel and stone. All the folks did a great job! Without these folks and the Pickerel/Crane Lake District funds, the landing would still be unusable.

For the folks who are wondering, the Town of Nashville owns all the boat landings in the district and the Lake District owns all the boat docks on Pickerel and Crane Lake landings. We install the docks in the spring, maintain and remove them in the fall, and this is all done by volunteers. What about all the signage at the boat landings? If you guessed that this is the result of the Lake District, your guess would be right. So, while the town owns and is responsible for maintaining all the boat landings, we funded this project and took over to make sure it was usable for Crane Lake.

Secondly, our Lake District Commissioner Curt Haga, the Forest County Tourism Committee and the Town of Nashville teamed up to greatly improve the access to the northside Pickerel Lake boat landing. If you haven't checked this out yet, take a look. Curt says it looks like we may be having more landing maintenance in the future.

Finally, I would also like to make it clear that the north and south Pickerel Lake landings, in addition to the Crane Lake landing, are not scheduled for major improvements. The landings are simply getting the maintenance they have needed for quite some time.

Hope this helps clear up some questions. Thanks for your time and interest in our lakes,

# **Aeration Report 2022**

Our aeration "Boss" Jerome Heiptas advised that the system started January 4, 2022 and stopped on March 5<sup>th</sup>. Unfortunately, on the night of the jump-in at Sportsman's Lodge, one male snowmobile rider ran through the safety fence and was thrown from his machine. Luckily, he was not seriously hurt and did not enter the open water.

The District Board of Commissioners and the folks in the district would like to thank the volunteers who installed/removed the safety fence this year. They are; Keith Verhaegen, Dan Welhouse, Dennis Welhouse, Mark Donnermeyer, Gene Ebben, Gus Turk, Mark Starich and Mat Kercisnik. These volunteers and their efforts may have saved a life, and again this year, avoided a winter fish kill. Due to their help, the lake has not had a notable winter fish kill since the aeration system was installed many years ago.

We would also like to thank the Smith family who are located on the north side of Pickerel for allowing us to have our aeration system on their property.

## **Fishing Report**

There will not be a stocking of walleyes in either lake this fall as we are now on the schedule for odd-numbered years. There will be a fall shocking to determine fish densities in both lakes.

We have had numerous reports of small walleyes 6"-7" being caught. These could be stocked fish from the fall or hopefully these might be 2-year-old naturally-reproduced fingerlings. This initiative began in 2012 and has taken us 10 years to rehabilitate the walleye population. Much time, effort, and money donated on the part of the Lake District, the Mole Lake Fish Hatchery and the DNR, has gone into this project. Remember: This is not an unlimited resource. # Lake Management Plan Initiatives Crane Lake Eurasian Milfoil Initiative

We have been approved for a 3-year grant to locate, manage, and remove pockets of Eurasian milfoil beds on Crane Lake. White Water Associates began work on Crane Lake on June 18<sup>th</sup>, locating beds of Eurasian Milfoil and applying GPS coordinates to those areas. Aquatic Plant Management spent one day on Crane Lake on July 21<sup>st</sup>. Following their extraction process, White Water Associates will conduct a follow-up survey to determine the effectiveness of the removal process. This work will continue through 2024.

## **New Signage at Boat Landings and Culvert**

As of this writing, we have two new signs entering the culvert from Pickerel Lake. We are asking boaters to

either physically remove all weeds from their props and anchors BEFORE entering the channel. This will help slow down the transmission of Eurasian milfoil from Pickerel into Crane. Although the water flows from Crane into Pickerel Lake, the majority of the milfoil discovered by White Water is located in the channel. Hopefully this can be removed by Aquatic Plant Management divers, as mentioned in the Lake Management Plan Initiative article.

We have a new boating regulation and hours for recreational use on Crane Lake. We are asking that after 6:00 P.M., no wave runners, tubing or skiing take place until 9:00 A.M. the following day. This regulation came directly out of the Lake User Survey as a majority of the people responding thought that a no wake regulation at 4:30 P.M. was too early. Please inform people of this new rule, so that we can all enjoy the lake. Thank you.

# **Aquatic Plant Harvesting Summer of 2022**

This is one of those summers that we haven't seen in over 20 years due to the lack of weeds. The harvester wasn't launched until July 11<sup>th</sup>. This was one of the latest launches in our history. We soon realized that the lake level was about fourteen inches lower than usual. Due to the shallow landing, we had our hands full trying to get the machine off the trailer. With some quick thinking by Snow Club tractor operator Marty Birschbach and some great equipment, we finally were able to free the machine. It was tense for a while!

The Sunday prior to the unloading I went around the entire lake and didn't have to unload any weeds from my boat propeller. This was a first for me. I know the older folks on the lake can remember the weeds so bad that you could hardly cross the lake with your boats. As of the middle of July there has only been one load of weeds harvested from Pickerel Lake.

The district encountered a problem with getting fuel for our trucks and harvester. The Town of Nashville advised us that we would no longer be able to get our fuel through the town. Mr. Jim Huss, our Harvester program "Boss", came to our aid. He was kind enough to allow us to use his indoor fuel tank on his property. Insight FS will provide us fuel and we will now be tax exempt and the fuel will be purchased at a reduced rate. The district is again very grateful to Jim for his generosity.
