Northwoods Six-County Lakes Meeting July 12 - "Protecting Our Waters: We're All Connected" is the theme for the annual Northwoods Six-County Lakes Meeting, set for Friday, July 12th at Nicolet College. Lake association leaders and members along with the general public will convene to learn about and discuss our interconnected water resources and our human connections to each other and to our lakes, streams, wetlands and groundwater.

Wake Boats

A bill proposed by Rep. Robert Swearingen (R-Rhinelander) and Sen. Mary Felzkowski (R-Irma) to regulate wake-surfing and wakeboarding fails to provide any meaningful

protection against the activities' impacts. Rather than setting minimum levels or protection for Wisconsin, the bill (as written) would actually limit the regulation of wake-sports.

The bill prohibits wake-surfing and wakeboarding within 200 feet of the shore or structures like piers and swim rafts. The overwhelming majority of studies say that at least 500 feet is required for these "enhanced wakes" to lose their size and power.

Current studies are showing that impacts to lakebeds, from the creation of enhanced wakes, are seen to depths of at least 20 feet. Lakes across Wisconsin are seeing pollutants in the lakebed kicked up into the water column and aquatic vegetation being scoured. The bill fails to include a standard related to depth. The minimum standard for Wisconsin should prohibit enhanced wake creation in waters shallower than at least 30 feet

Most recently, a number of proposals have been delivered to the state legislature, and even petitions to the DNR trying to regulate wake-boarding concerns among Wisconsin residents. Some local townships have even conducted meetings and debated the topic among citizens. Some calling for an all-out ban on wake-boating, while others asking for some type of regulation. This hotly contested issue in the state of Wisconsin is far from being resolved.

Walleye Stocking 2024 and Survey Results - Brad Kupfer

An electro-shocking survey was conducted on Crane Lake last September to determine the health of our walleye population. There were zero age-0 walleye caught (which is the first time we have not caught one since the reef was installed. Although water clarity was quite poor (about 6-12"), we did get 6 age-1 walleye which would be naturally reproduced fish, and 15 other walleyes from 12-16.9".

Mole Lake Fisheries walleye stocking occurred last October with 3,410 walleye fingerlings going into Crane and another 12,841 fingerlings being stocked into Pickerel. Average size of those fingerling walleyes was 7.42". Remember, walleyes must be a minimum of 18" and 3 may be kept. Please practice catch and release of larger walleyes as they are the reproducing females that are so critical to growing and sustaining our walleye population.

Bullhead Extraction for Crane Lake - Brad Kupfer

Numerous conversations occurred last March with Mike Preul, Mole Lake fisheries director, and Greg Matzke, DNR fish biologist, where the bullhead issue and the need to remove those fish on both lakes was discussed. After much discussion, Mike and Greg decided to focus their efforts on Crane and postpone Pickerel until later. Greg has agreed to let our District volunteers use the DNR's Fyke Nets on Crane Lake. Mike has agreed to help place the nets on Crane Lake, capture the bullheads, and then dispose of them. We will need volunteers from Crane Lake to help with the nets, and a place to put the bullheads once extracted. Please contact Brad Kupfer (715-484-2520) if you are willing to assist with the removal.

LMP Update - Brad Kupfer

This will be the last year of our three-year Eurasian Milfoil grant that was approved by the DNR in 2021. This June, White Water Associates will be conducting the survey maps identifying areas of Eurasian Milfoil. Those survey maps will be forwarded to Aquatic Plant Management for removal via DASH (diver assisted suction harvesting) shortly thereafter. We still have a major concentration of milfoil in the channel that is coming from Pickerel Lake on boats. Please observe the sign near the culvert on the Pickerel side of the culvert asking boaters to clean their props before entering the channel. Thank you for helping us control further spreading of Eurasian Milfoil.

Crane Lake Limnology Study

Dean Premo from White Water Associates will be in attendance at our spring meeting to review the Limnology Study (water analysis) conducted last summer.

Septic Survey for Crane Lake - Brad Kupfer

In conjunction with the Limnology Study on Crane Lake, a septic survey was conducted on Crane and Pickerel Lakes providing Forest County Zoning with all of the addresses on both lakes. We now have a complete list of all properties on both lakes, their last mailing of the 3-year scheduled maintenance,

when it was returned, and when the next mailing is due. Compliance and accountability for all of us will be the key focus in the future, so please take care of your septic system or holding tank, so that we can eliminate this factor of potential phosphorus and nitrogen being leaked into our lakes. For example, one (1) pound of phosphorus into the lake can yield over five-hundred (500) pounds of algae.

Shoreline Improvements - Brad Kupfer

Last summer, as we were boating around Pickerel and Crane Lakes, Kathy and I noticed several properties that had recently made positive enhancements to their shoreline. These ranged from adding rip-rap, adding native plants, or just letting the natural vegetation grow along the shoreline. All of these simple enhancements can have a significant impact on preventing run-off from entering the lake. Studies in the Midwest have found that lakes with clearer, cleaner water commanded higher property values. It was also discovered that when water clarity went down 3 feet, property values also went down by the tens of thousands. Please visit our website for shoreline restoration and improvement ideas. Collaborative Approach Funds Boat Landing Repairs & Improvements

All three boat landings: Pickerel Lake – North, Pickerel Lake – South, and Crane Lake were in need of extensive repair. The launch areas had been damaged by the power loading of boats (which created large holes) and the yearly spring ice-out (which moved the small deteriorating concrete planks.) Curt Haga led the planning, fundraising, permitting, and overseeing of the 2-year project which was developed to address deferred maintenance with a longer-term solution while minimizing the cost, improving safety, and addressing environmental issues.

The improvement efforts started in 2021 with Pickerel Lake – North, the most heavily used of the three boat landings. The shoulder on Pickerel Lake Road, across from the boat landing entrance/exit, was widened to increase the number of parking spots and improve pedestrian safety. Trenches were dug and infiltration trenches were added to redirect runoff, minimize erosion, and reduce water runoff into the lake. Decreasing the grade of the driveway entrance/exit helped with line-of-sight

exiting and improved vehicle traction while towing boats up the hill. Nice job done by Charles Jackson Trucking & Excavating. (Chuck Jackson and Jimmy Wagnitz).

Early 2023, grants and contributions were received to fund repairs and improve all three boat launch areas. During the summer, Krueger & Stienfest, Inc. (K & S) began pouring the large (6' x 12' x 9") concrete planks. During the fall, the holes in the lakebed were filled, and the 9,000-pound concrete planks were carefully lifted and placed in the boat launch area. The planks (which extend out to where the holes were filled) are linked together with 1' rebar creating a ramp. To complete the work, gravel was added and finish grading was done near the approach to the boat launch areas. Nice job by Tim, Corbin, John & Brandon of the Krueger & Stienfest team.

Thanks to the assistance of Steve Kircher (Forest County Conservationist) in obtaining DNR permits and the DNR grant application, we were fortunate to be awarded a DNR Waterways Grant which accounted for half the total project cost. Furthermore, these projects would not have happened without the grant funding from Visit Forest County (Formerly known as Forest County Tourism Commission) and generous contributions from the Pickerel-Crane Lake P & R District and the Town of Nashville room tax funds. No Town of Nashville general operating funds (property tax dollars) were used for this project. Time will tell if Mother Nature (ice) moves the new and heavier planks. Hopefully, the repairs/improvements will last for many years.
