1.a New Service Connection Fee per EDU (EDU = Equivalent Dwelling Unit, Includes meter & 1" tap for residential)	\$1,670.00
1.b Residential Meter Only Charge - Replacement or New	\$430.50
2. 2" and larger meters and taps	Installed by Owner
<b>Existing Services</b>	
3. Remove, Test and Replace Meter <1"	No Charge (< 1 per year)
4. Replace & Repair Frozen or Damaged Meter or Meter Apputenances	1 Hr Labor/Overhead plus cost of materials
5. Shut Off and Turn on Water at Curb per Request	No Charge (< 1 per year) or 1hr Labor/Overhead each
6. Shut off/On Water After Normal Work Hours	1.5 Hr Labor/Overhead Each
7. General Hourly Labor and Overhead Rate	\$68.25
8. Stopped Meter Notice or Unauthorized Use of Water	\$75 per Quarter plus Estimated Usage Charges
9. Replace Cover on Curb Box	1 Hr Labor/Overhead plus materials
10. Raise, Lower or Replace Curb Box	1 or 2 Hrs Labor/Overhead plus Materials

11. 6" Hydrant	\$45.90
12. Commercial/Industrial Less than 4" Fire Line and/or fire sprinkler system	\$55.00
13. 6" Fire Line and/or fire sprinkler system	\$91.90
14. 8" Fire Line and/or fire sprinkler system	\$138.20
15. 10" Fire Line and/or fire sprinkler system	\$225.00
16. Residential less than 2" for fire sprinkler system	\$0.00

Minimum Quarterly Water Charge (1,000 Cubic Feet or 7,480 gallons)	\$44.10
Water Usage (After 1,000 Cubic Feet)	\$5.63 per 1,000 gallons
Bulk Water Tanker Rates	\$16.60
Surcharge for Estimating Water Usage	\$25 per billing cycle
Surcharge for Not Allowing Access after 90 days (Stopped Meters, etc.)	\$75 per billing cycle
Failure to Remove a Prohibited Device, Install/Certify Backflow Device & Other Rule Violations	\$250 for 1st Qtr, Additional \$250 per Qtr thereafter
Meter Reading Fee for non ERT (Old Style Only)	\$50.00
