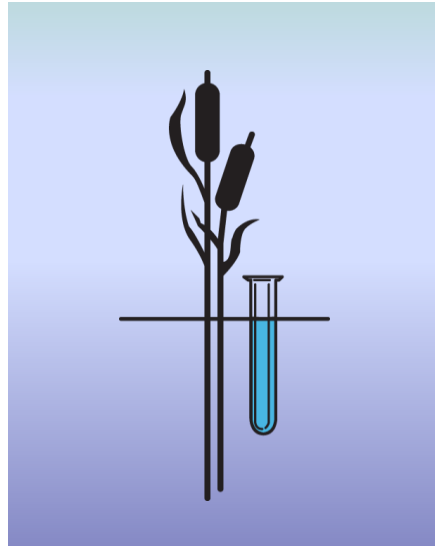
ABOUT US
