Asked why she doesn't want to run in Ridgeway, which is closer to where she lives? She said because Dan is here.

John did tell Ann that the Chief would not be able to discipline her at all if need be. That would have to come from the Captains or the Trustees. Ann understood this.

Ann was told that if hired she will have to get a physical, a background check, a drug screening and would have a 1-year probation. Ann was fine with all of this.

They thanked her for the interview, and we will be in touch with her in the next few days. Ann left the interview,

The Captains and the Trustees discussed among themselves as to whether to hire Ann or not. It was also brought up that there is a 1-year probation if hired. After some discussion, Kenny made a motion to hire Ann McElfresh for the PTFD, seconded by JD. John, yes, JD, yes and Kenny, yes.

All agreed to let the Chief know their decision and then he can let Ann know she was hired and welcome to PTFD.
