The purpose of this meeting is our Year-end meeting.

All stood and said the Pledge of Allegiance.

Mr. Brose reported that the cemetery bases have been poured and the frames were removed yesterday.

Mrs. Stalling brought up about sending Resolution #08-09-21 to the landowners out there concerning non-maintained drives. There have been some questions about cleaning up a drive out at Fout's. Trustees read the letter Mrs. Stalling wrote to the land owners. The Trustees made some modifications to the letter. After she makes the modifications, she will send a copy to the Trustees to approve and then she will send the letters to the property owners.

Cindy received a recall on the 2017 grass truck. They will let us know when the part is in, so we can take it in for the recall.

We received our Road Mileage Certification from the County Engineer, Trustees needed to sign the copies and return one to the Engineers Office.

Cindy received a letter from Robinaugh about the FF/EMS needs to get signatures on run sheets. When they don't get a signature, then Robinaugh has to send the run sheet to the patient to sign and sometimes it takes two forms sent before it gets signed. Robinaugh stated that if this continues to happen then they will start charging for the postage.

Cindy brought up about doing Temporary Appropriations, then we can write checks in January. Cindy can do these appropriations and then we won't have to have an Appropriations meeting in January. After some discussion it was agreed that we will try this Temporary Appropriations this year and see how it goes.

Nikki Yelton gave her report on the rooms for December. Lodge was rented 12 times. 7 non-profits, received \$200.00. The Community Room was rented 13 times and received \$40.00 in donations.

Nikki reported that as for calling the annuals that rent certain rooms every time each year. Nikki said that she was going to ask them when they rent the room at that time, if they want it again this time next year. After lots of discussion, at this time there will be no annuals called, it will be 1st come, 1st serve starting on the 1st business day of the year.

Jessica Gibson reported that the Fire Dept recliners should be delivered either today or Monday.

Renee Rosebrook reported that she will be working on our website. She wants to call GoDaddy and talk to them about our website.

Fire Chief, Doug Henry, reported that he has received a couple interested in employment. He is going to set up interviews. Mr. Rosebrook stated that if Chief wants the Trustees to sit in on the interviews, they are willing to do that.

It was brought up as to if Chief got ahold of Kyle Richards, is he interested in coming back to work or not? Jessica contacted him on Dec. 13 and he said he will prolly sign up, but she hasn't heard anything from him since then.

Chief reported that the fire department went to Mr. Melvin Louden's, who is a Veteran and lives on C.R.2, and the department put in a couple smoke detectors. And a hallon extinguisher has been donated to him, the department has to set up a time to set that up for him.

Sandy brought up about there being tools on the truck and they are in a plastic tool box that is broken. She had a print out of a Pack Out that is \$69.99. This is on E-41. Sandy would also like to have an impact drill driver, and a charger for it. She had a print out on these too. We can get the impact drill driver from Milwaukee at McAuliffe's for \$600.00. They also have 2 batteries for \$130.00 or a big charger for \$250.00, which has 6 batteries. After some discussion, Mr. Rosebrook made a motion for said purchase at McAuliffe's, seconded by Mr. Gibson. Brose, yes, Rosebrook, yes and Gibson, yes. Sandy will go get these items. Mr. Brose will call McAuliffe's and have Sandy's name put on the account so she can purchase these items. E-42 doesn't have a tool box on it.

Nikki brought up about getting a new sweeper for the Community Room. She would like to have a Shark. Chief reported that the fire dept could use a new sweeper also. Kenny made a motion for 2 new sweepers, seconded by JD. Brose, yes, Rosebrook, yes and Gibson, yes. Renee looked up on Amazon and the price for a Shark sweeper was \$159.00.

Kenny reported that we got a new ink cartridge for the time clock at the firehouse. This will help, as it was getting very hard to read the times.

The water at the Community Room was frozen on Christmas Eve. Kenny spent several hours there getting it fixed.
