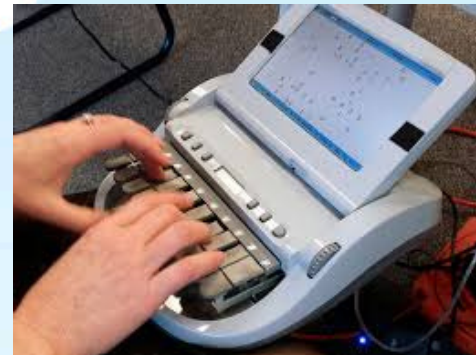
TAX CREDITS AND REPORTING WITH JAMES CONACESSA

The session will begin with an analysis of introduction on paid sick leave tax credit. The purpose of the Presentation will be Understanding the 2021 Paid Sick Leave and Family Care Tax Credit. Some of Mr. Conacess's Key takeaways that he will leave attendees with will be What is the Paid Sick Leave and Family Care Tax Credit? The purpose of Legislative Context. The remainder of the session will cover an overview of the tax credit introduced in 2021 and part of the American Rescue Plan Act (ARPA) along with some of the most frequently asked independent contractor questions. Attendees will leave with knowledge and understanding of how the Credit Works and a clear Explanation of how to claim the credit, IRS Procedures, and how to report the credit on tax forms.

Qualified court reporters that pay self-employment tax (15.3%) can receive a refund from the IRS for tax year 2021, through the paid sick leave act.. RETCS Partners will leave you with a clear understanding of the credit as outlined in the Families First Coronavirus Response Act (FFCRA) and the American Rescue Plan Act (ARPA). Tax preparers are not so familiar with the credit, and its complexities.

.The government has set aside millions for you, and we will guide you to collect your refund, and have a check in 30 days. The clock is ticking, the paid sick leave credit expires this year.

ARE YOU QUALIFIED?

If you are a single-member LLC, a sole-proprietorship, 1099 subcontractor etc. As long as you filed a Schedule C for 2020 and/or 2021 you are considered self-employed.

COVID EFFECT WORK DAYS
