By signing you agree that by any chance you are unable to take care of or keep your puppy you've purchased from Labradors of Montana or North Western Labradors then it is your responsibility to return your puppy to Labradors of Montana or North Western Labradors at no cost to the breeder. The breeder is not responsible to refund any amount. You are not under any circumstances to take your puppy to a shelter or pound.

Here at Labradors of Montana and North Western Labradors we care very deeply as to where our puppies go and where they end up. We do however understand that sometimes life happens; and therefore, we would be happy to take your puppy back.

Puppies are guaranteed to be free of illness for 5 days after leaving our premises. As long as insurance certificate has been activated within the 24 hour time. Required by them.

Puppies are guaranteed against life-threatening genetic defects until their 2nd birthday. All of our puppies have been dewormed with pyrantel and Fenbendazole at least twice before leaving our home. Parasites are NOT included in the health guarantee. Your puppy has been given a parvo distemper vaccine at least once before going to their new home.

You voided your guarantee

If you vaccinate this puppy or administer other stressful toxins spot ons oral flea and tick or any other chemical within 7 Days of receiving your puppy you void your warranty. We specifically do not recommend NexGard at any age.

Or you choose not to feed Pawtree or any other agreed upon food.

If your puppy were to come up with any puppy diseases or illnesses (excluding kennel cough, parasite worms, coccidia or giardia. These are not covered by the health insurance or the guarantee provided to you from labradors of Montana or North Western Labradors.) that is not covered by the health insurance provided to you from Labradors of Montana or North Western Labradors within the first 5 days after leaving here. You would be entitled to an exchange as soon as a new puppy is available. We do need veterinarian proof that this was a disease and NOT neglect dropping or poisoning or any other thing that you the new owner may have done to this puppy. It is your responsibility to provide this proof. **It is also your responsibility to activate the insurance provided to you by Labradors of Montana or North Western Labradors within 24 hours of receiving your puppy. The date will be on your certificate.**

If a major illness does arise within the 5-day period, Labradors of Montana or North Western Labradors will reimburse you upto 10% the insurance does not cover, Labradors of Montana or North Western Labradors will provide you with the insurance voucher so that you can activate your 30-day free trial right away. If you choose not to activate your 30-day free trial you will be responsible for ALL vet bills and Labradors of Montana or

North Western Labradors will not be held financially responsible for any treatment of any kind. Labradors of Montana or North Western Labradors does not require that you continue coverage after the 30-day free trial. That is your choice.

Food: You must feed PawTree food in order for us to guarantee any puppy. You may be required to prove what you are feeding if something does occur. The best form of proof is in the form of a receipt. If your puppy has a life-threatening genetic defect before it's 2nd birthday you are entitled to a replacement puppy as soon as one is available. Again, I will need veterinarian proof of the defect. Please understand that since I have no choice as to how many vet bills you run up and how many services YOU choose to do, we only offer a replacement puppy. If any life-threatening genetic defect were to arise please contact me as soon as possible so that we can discuss possible replacement options. If at any time "I" am required to pay for vet or other expenses not covered by the health insurance provided to you for the 30 days at no cost to you, these expenses shall never exceed the original purchase price of the puppy. If you wish to return your puppy after I have paid for the vet bills or other fees you will be entitled to a refund of the remaining amount but never to exceed the purchase price of the puppy. Purchase price is separate from the shipping price. Puppies also must be returned within 5 days of the date of this contract to obtain a refund, along with proof of the defect. All transport fees are solely the responsibility of the new owner. It is often a good idea to give me a call before taking your puppy into the vet if you suspect it is ill within the five-day period. As it may just be a simple parasite, or I may choose to exchange your puppy at that time and take it to my vet. By signing below you agree to this contract and to spay or neuter your puppy between 6 to 12 months of age. You also agree not to breed your dog ever. All of our puppies are sold with limited registration (no breeding rights or limited registration,) unless full breeding rights was previously discussed with your puppy.

Nuvet

We highly recommend giving your puppy Nuvet and Nujoint.

Contract must be signed by both parties to be valid. If you do not sign, your puppy will be sold as is with no guarantee and we reserve the right to not sell it to you at all.
