- Marketing for the event will include signs, email blasts to all local Genesis Health Club members and social media posts. Vendors with an established customer base are encouraged to invite their customers.
- Each vendor is required to collect and remit sales taxes to the State of Kansas using the Special Event Kansas Retailers' Sales Tax Return which will be provided to you the day of the event.
- Security is not provided on the day of the event. Genesis Health Clubs will not be responsible for lost, stolen, or damaged items.
