**It is hereby resolved** that the Town of Cormack will borrow the sum of Five Hundred Thousand Dollars (500,000.00) from the Bank of Montreal in Deer lake. The purpose of this loan is to finance the purchase of a new loader complete with snow blower attachment. . The loan would be amortized over ten years with a five year term with a monthly payment of Four Thousand Nine Hundred Thirty Two Dollars (4,932.59) including interest per month. At a fixed interest rate of 2.97 percent. The Town will pay any GST expenses from its own operating account.
