## Renewable Energy Feed-in Tariff Scheme

In response to climate change, CLP and HK Electric have introduced a renewable energy Feed in Tariff (FiT) scheme since 2018, respectively. Through the plan, solar power owners can sell the generated electricity to CLP or HK Electric at HK\$3 to 5 per kilowatt-hour of electricity to make a profit and enjoy the following benefits.



**4-year payback period:** The investment payback period of the solar power generation system is locked for 4 years, so that the owner can stably earn the high-priced electricity bills afterwards



**Annual return rate of up to 20%:** After deducting the investment cost of the solar power generation system, the electricity sold can bring about 20% return to the owner every year, or subsidize future electricity bills.



**The plan is valid until 2033:** The feed-in tariff remains unchanged during the contract period of the approved project, and the validity period can be as long as the end of 2033.

## How will I benefit?

You can take part in the scheme by installing a solar and/or wind power renewable energy system on your premises. Once the system is successfully connected to the CLP/HK Electric grid, you can earn FiT payments.

- ✓ The on-grid electricity price is collected according to the meter reading.
