- Call CHIRLA for immediate assistance so that an attorney and legal observers will come: **(888) 624-4752**.
- Immigrant Defenders Law Center (ImmDef) can help fight your case in immigration court. Call the rapid response legal resource hotline at **(213) 833-8283**.
- **Detainee locator:** The government has different offices that deal with immigration. If someone you care about was arrested and you think they may be deported, it helps to know which government office might be holding or detaining them.
 - Different agencies include Immigration and Customs Enforcement (ICE), Customs and Border Patrol (CBP), The Bureau of Prisons (BOP), and Military Bases (Guantanamo Bay).
