### Potential health effects

#### Primary routes of exposure:

#### 4. First-Aid Measures

#### General advice:

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. # <u>Handling</u>

#### **Storage**
