Source of Drinking Water

The sources of drinking water (both tap water and The sources or drinking water (buth tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the land of t nind, in some cases, radioactive material, and can pick up substances resulting from the presence of unimals or from human activity.

Contaminants that may be present in source wate

include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gaproduction, mining, or farming.

Pesticides and herbicides, which may come from variety of sources such as agriculture, urban storm vater runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which as by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems. micals, which are

Radioactive contaminants, which can be laturally-occurring or be the result of oil and gas roduction and mining activities.

Drinking water, including bottled water, may prinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population.

Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The drinking water supplier is responsible for providing high quality drinking water and removing lead pipes, but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standard Institute accredited certifier

Source Water Assessment

Source of Water: PAYSONTo determine Payson's susceptibility to groundwater contamination, a Well Site Survey, published in 1989 by the Illinois EPA, and Source Water Protection Plan were reviewed. Based on the information contained in these documents, no potential sources, routes, or possible problem sites are located within the 1,000 foot survey radius of these wells. However, one potential source of groundwater contamination is present outside of the1,000 foot that could pose a hazard to groundwater pumped by the Payson community water supply wells. This potential source of contamination is Sunoco Service Station.Based upon this information, the Illinois EPA has determined that Payson wells #2 and #4 are not susceptible to ICC, VCC, or synthetic organic compound contamination. This determination is based on a number of criteria including monitoring conducted at the wells, monitoring conducted at the entry point to the distribution system, and the available hydrogeologic data for the wells.

Water Quality Test Results

Definitions:

The following tables contain scientific terms and measures, some of which may require explanation.

Regulatory compliance with some MCLs are based on running annual average of monthly samples.

Level 1 Assessment:

A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

Level 2 Assessment:

A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

Maximum Contaminant Level or MCL:

The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or MCLG:

The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum residual disinfectant level or

The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
