Source of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water

include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be aturally-occurring or be the result of oil and gas roduction and mining activities.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The drinking water supplier is responsible for providing high quality drinking water and removing lead pipes, but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standard Institute accredited certifier

Source Water Assessment

The source water assessment for our supply has been completed by the Illinois EPA. If you would like a copy of this information, please stop by City Hall or call our water operator at 217-430-5411. Source of Water: FLAINVILLETO determine Plainville's susceptibility to groundwater contamination, a Well Site Survey, published in 1989 by the Illinois EPA, was reviewed. Based on the information contained in this document, and a subsequent survey in 2008, twelve potential sources of groundwater contamination are present that could pose a hazard to groundwater pumped by the Plainville community water supply wells within the minimum setback zone or the 1,000 foot Phase I Wellhead Protection Area (WHPA). These include an open dump, a pesticide/fertilizer commercial application or warehouse, four below ground fuel storage, vehicle parking, a septic storage/disposal, an above ground fuel storage, an abandoned or improperly plugged well, an automotive repair business, and a food processing business. Records indicate Well #2 has subsequently been properly abandoned. Based upon information provided by Plainville water supply officials, the following facilities listed as potential sources in the SITE DATA FOR THIS FACILITY table no longer exist: unknown garage underground storage tank, Adams FS Inc., Grigg's Grocery Store, and Standard Oil Station. The Illinois EPA has determined that Plainville Wells #1, #4, and #6 are susceptible to IOC, VOC, and SOC contamination. This determination is based on a number of criteria including: monitoring conducted at the wells; monitoring conducted at the entry point to the distribution system; and the available hydrogeologic data for the wells. Approximately forty percent of the combined Phase I WHPA land use of all three wells is utilizeded for agricultural purposes, and remainder of the land use is residential and business. Sampling performed to assess for pathogenic contamination (e.g., virus, total coliform, e-coli) has also demonstrated that the source water is not susceptible to these types of contaminants.

A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

Maximum Contaminant Level or MCL:

The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum residual disinfectant level or
