New Business

<u>Discussion and Approval of Resolution 2020-02 for use of Motor Fuel Tax funds for street</u> maintenance and repairs

Trustee Scott made the motion to approve Resolution 2020-02 not to exceed \$25,000.00 of Motor Fuel Tax funds including Engineering Fees to Fehr Graham for street maintenance and repair projects through Spring 2021. Trustee Robertson seconded the motion.

Board Comments

Mayor Evans issued a statement regarding enforcement of ongoing violations throughout the village and urged the public and members of the board, himself included, to avoid interfering with Chief Shumate's processes. Further stating that it undermines the Chief's authority to address such issues which causes problems because it can be interpreted as speaking on the Chief's behalf. That is not the case. Please allow the Chief to continue to be effective and efficient in his job as he has done a great job so far.

Trustee Curry stated that the Chief has now passed his six-month "probationary period" of employment so the increase to his salary, previously agreed upon at the time of hire, should take effect immediately. He wishes to thank him for his service over these last six months, he has done more than the last few Chiefs altogether.

Treasurer Leon Albers stated he would do so and added that Chief is doing a tremendous job in his patrols, his information about the budget and his communications have been excellent.

Public Comment

Jim Richardson wished to address the accumulation of unsightly trash at the property by the barbershop again and requested Chief Shumate follow up on the status of additional clean up.

Bill Kurth requested information regarding the damaged tree in the easement that was promised to be removed after the last storm. Public Works Superintendent Chad Polsky stated bids are still being received with only one respondent thus far. Bids from B&M tree service and Petmecky bids are pending as we try to use local contractors as often as possible before issuing a request with another vendor.

Betty Kurth requested the Chief come and look at a fence that is falling over. Chief says it is on his list to address for public appearances in the near future.
