- 1. Call to Order
- 2. Opening Remarks There is an allegation by prior board members that they cannot be involved in a board for two years. This is false. The board requested the Watermaster lock the second meter but it is frozen/jammed and so will require service of a plumber. In the meantime account will be billed as normal. Water master will contact a plumber to get the meter locked or removed. There is one member account in arrears on a vacant Treasurer is in contact with member to get the arrears remedied. We are currently waiting on 2020 POA income taxes to be completed by CPA. Committees need to think about what upcoming expenses will be needed for next year budget.
