PROGRESS:

- ➤ The board is constituted, officers appointed, and first level trainings for officers occurred. A thank you to Beverly Davis and Martha Wilkerson for the smooth transition.
- Amended Secretary of State (CA) filings are complete and approved, and have updated authorized signatories with TriCounty Bank.
- Have conducted two board meetings with membership participation at both.

IMPORTANT INFORMATION:

Water Conservation: As you may be aware, we are experiencing extreme drought conditions in much of our state. Shasta County has been labelled as exceptional drought (US Drought Monitor). Although the state and Shasta County have not imposed mandatory water conservation measures, we encourage all our members to voluntarily reduce water consumption during this time.

Fire Watch:

Beaty has provided notification that access to their property is closed, including to walkers. Please refrain from walking on Beaty due to high fire danger.

Gun Shots – on June 20th in the late afternoon, over 150 rounds were shot off in rapid succession somewhere to the south of our community. This is an extreme fire and personal safety danger. Should you hear gun shots, please contact the Shasta County Sheriff's Department – (530) 245-6540 directly to report the situation. The more we report, better the response from the Sheriff's Department.

- ▶ By July 7th, you should receive your mail in ballots for the election of the interim board.
- August 9th is our next scheduled board meeting (4:00 p.m. at Van Stellman Hall).
- Note: due to a couple of unresolved issues in our new drafted CC&R/Bylaws, legal counsel has recommended that we postpone the vote on these documents until our next annual meeting in March 2022. We still wish to transition from being an appointed interim board to an elected board, so confirmation of the new board remains on the ballot.

Outlined below are our committee reports for the second quarter. All Chairs are your new interim board members and many of the committee members are new to these committees. The updated committee roster can be found on our website (woodridgepoa.org) on the "Your Committees" tab.

Advocacy & Community Safety

Assist, Support, and Respond – Outreach within and for our Community With the inaugural meeting, Advocacy & Community Safety met to discuss broad ranging topics that supports the mission of the committee. Highlights include:

- Identifying those in need that may include our very elderly, widowed, etc., to assist and support them with tasks such as: yard and property maintenance, wood splitting and stacking, and running of errands, as well as checking in just to say hello.
- Initiating contact with Shasta County about having our cracked/crumbling roads repaired/repaved.
- Research the costs about purchasing "Slow Down" and "Fire Exit" signs for our community.
- Place a notice board on the exterior of the Shingletown Store for our association so that we can post notices of meetings. Cost is currently being reviewed.
- Committee members, Valerie Szody and Kristyn Koppman walked the entire community
 going door-to-door handing out the "Save the Date" flyer for our upcoming elections for the
 board. For those they interacted with were very supportive and welcoming. Almost half of
 the community were home, and for those who were not, the notices were taped to their
 door or mailed, and the balance were emailed.

Design & Architectural

Most are currently clearing for construction. We look forward to see the completion of the
Chateau lots, and the others include lots 18, 59, and 77. As a reminder, for any perceived

Lake Management & Oversight

Caring for Woodridge Lake as a Vital Member of our Community

- Permits for aquatic weed control have been submitted to both the State Water Resources
 Control Board and California Department of Fish and Wildlife and they are working their
 way through the process. We are hoping they will be finalized by the first half of July.
- The committee met with Ajay Jones, the SePRO representative regarding recommendations and the application of sonar. Also, we are currently gathering pricing information.
- We are hoping to apply the sonar in mid-July, pending permits, and we should begin to see results in approximately 30 days.
- There is no downtime required after sonar goes in. We will post a notification on our website (woodridgepoa.org) when we have a specific application date.

Legal Oversight

The draft of the new CC&Rs and By-laws that were presented as part of the documents for the last annual meeting on May 1st, is still pending as there are a few provisions that require additional attention. The interim board intends to resolve these items and provide you with the updated drafts in advance of our next annual meeting of March 2022 and vote accordingly.
