



Service Agreement/ Terms & Conditions (“T&C”)
of the World Greatness Awards Ceremony & Event
in Zanzibar in October 2025



The following terms & conditions shall govern the attendees (observers, guests, alumni and honourees) to the World Greatness Awards 2025 in Zanzibar (“Awards” or “Event”) organised by World Greatness Ltd trading as Greatness University “We”, “Our” or “Us”). Event shall also include any event organised by World Greatness Ltd including but not limited to the awards, conferences or workshops. World Greatness Ltd reserves the right to edit these T&C, with or without notice to you, at any time. 1. Package/ Pass/Ticket to the Awards and Event: You are required to purchase a Package or Pass or Ticket at the price determined and announced by Greatness University at www.worldgreatnessawards.com to attend, view and/or access the Awards and/or Event, unless otherwise specified by us.
2. Payment Term: You must pay World Greatness Ltd for the package/ pass/ticket ordered via the payment methods and within the payment due date specified by World Greatness Ltd.
3. No Refund Policy: There will not be any refund for any package/ pass/ticket ordered or purchased, unless otherwise prior-agreed by World Greatness Ltd, on case by case basis.
4. No Transfer: Package/ Ticket/ Pass ordered and/or purchased, is personal to you and shall not be transferable or assigned. For virtual Awards and Event, Greatness University may provide you a URL link or digital access to attend and view the Awards show and/or attend the Event. You hereby represent and warrant that you shall not use any means whatsoever, to give or provide the said URL link or digital access, to any other party or person for their unauthorised viewing or access. You further warrant that you will not give unauthorised access to any third party or person who has not purchase a pass/ticket from Greatness University to attend, view and access the Awards and/or Event.



5. Physical or Hybrid or Online/Virtual Event: Greatness University has the full absolute right to determine whether to host a fully virtual event or hybrid or physical event, as it deems fit, without your consent.
6. Package/ Pass/Ticket Policy: You shall comply with the policy set by Greatness University from time to time.
7. You consent to be photographed, recorded, filmed and written about: The Awards and Event will be filmed, recorded, written about, taped and broadcasted to the public in any media now or hereafter known, worldwide. By attending the Awards and Event (either physical or virtual), you hereby irrevocably grant Greatness University and to its successors, licensees and assigns, in perpetuity:
 - (a) The right to interview, photograph, write about you, record, videotape and/or film you in and in connection with the Awards and Event (including but not limited to the production of the programme, show and/or conference);
 - (b) The right to use such interview as well as your picture, silhouette and/or any other reproductions of your likeness and any or all scenes, photography, videotape or film in which you appear in and in connection with the Awards and Event (including but not limited to the production of the programme, show and/or conference) and the broadcast, exhibition, exploitation, advertising and promotion thereof; and
 - (c) All right, title and interest in and to the results and proceeds of such interview, of photography, recordings and/or videotape rendered, in connection with the Awards and Event (including but not limited to the production of the programme, show and/or conference).

D) The right to use your biographies in our written and online publications and those of our partners.

Without limiting the foregoing, you acknowledge that the results and proceeds containing your appearance (including but not limited to your interview, biography, acceptance speech and all activities during your participation, attendance and/or appearance) can be used in the distribution and exhibition of the Awards and Event in any and all media now or hereafter known, throughout the universe, in perpetuity, and in any and all publicity and exploitation in connection therewith. You further understand that You shall not be entitled to



payment of whatever kind or nature in connection with Our use of your appearance (including but not limited to your interview, acceptance speech and all activities during your participation, attendance and/or appearance), and that AACA shall have no obligation to you, either monetary or otherwise. You shall hereby release Greatness University and its successors, licensees and assigns from any and all claims that You may hereafter have against Greatness University, in connection in any manner with the rights you are granting herein.

8. Rights to change any agenda and program: Greatness University reserves the absolute rights to change and/or cancel the published agenda, program, any speaker, any panellist and/or moderator, at any time without notice to you.
9. Right NOT to film, interview and/or broadcast your appearance. Greatness University has the absolute right not to film, interview and/or broadcast any of your appearance or acceptance speech or activities, as it deems fit.
10. Acts or Cause beyond Greatness University' control: Greatness University shall NOT have any liability for the failure to perform or a delay in performing any of its obligations hereunder, if such failure or delay is the result of any legal restriction, labor dispute, strike, boycott, flood, fire, public emergency, act and/or directive of the Singapore government, health/medical restriction and/or outbreak e.g. COVID 19, pandemic, revolution, insurrection, act of terrorism, riot, war, unavoidable mechanical and/or technical failure, interruption of electrical power or internet or any other cause beyond its control, for as long as such condition persists.
11. Governing Law and Jurisdiction: The law of England and Wales" will govern the contract.
