2025 BOARD INTRODUCTION

At this time, President Lou Ann Reichling introduced the 2025 Association Board; and recognized Debi Sanford of Chalk Mountain as the coordinator in the Central Coast Division.

REVISION TO BYLAWS

As per Bylaw Article X, Amendments, the Final Copy of the Proposed Amendments to the WPLGASC Bylaws and an informative memo were sent to the Presidents and Delegates of each member club on October 31, 2025. At this time, President Lou Ann Reichling asked that the member club representatives stand to vote. A count was made and the motion to adopt the proposed amendments to the WPLGASC Bylaws as a whole were adopted by 2/3 vote in the affirmative. The amendments are adopted and are effective immediately.

TREASURER: Susan Shimizu distributed the Balance Sheet and Profit and Loss Statements as of November 30, 2025. She also made available the 2026 Proposed Budget. Our fiscal year ends 12/31/2025 so the year-end Balance Sheet and Profit and Loss Statements will be available in January 2026, by request.

ANNUAL REPORTS:

Major Tournaments: Donna Buxton announced that we hosted 822 players at our six Major Tournaments, averaging 137 players per tournament. We paid out over \$29,780 in awards, which includes \$5,425 in ties. 2025 was the first full year that we paid ties at our major tournaments. This year flighting was done by handicap index at Majors as well as Association Day tournaments. This change results in fairer distribution of players and payouts across flights. Late this year we implemented scorecard verification, which expedites the scoring process, and a new scoring methodology was implemented. Many small

improvements have been implemented to make your day as enjoyable as possible, and much of that is thanks to the feedback that you've provided after each tournament.

Monthly Tournaments: Janet Herbold gave Kathy Takemura's report and reported that in 2025 we had almost 4,000 members participating in our Monthly Association Day Tournaments. Changes made during Kathy's two years as Monthly Tournament Chair were having some of the Association Day Tournaments prepaid, in hopes of eliminating no shows and last-minute cancellations; implemented a 10-stroke maximum during play days; document start and stop times on scorecards; and having groups document slow groups in front of them. We had three hole-in-ones at Association Day Tournaments by Sandy Dunn at Birch Hills, Mary Kurzeka at Santa Barbara and Rhonda Church at Strawberry Farms. All received \$300.

NOMINATING COMMITTEE REPORT: Marleen Hoel, Nominating Committee Chair, presented the following Slate of Candidates for election to the Offices and Committee Chairs of the Women's Public Links Golf Association of Southern California for the year 2026. This was distributed to all clubs via email in early November.

Lou Ann also thanked Diane Acosta for her two years as the Western Division Rep where she contracted with the courses, prepared tee sheets and scored the tournaments. Sue Jett was then recognized as a past president. She has served on the WPLGASC Board for many years. She was appointed in September 2015 to replace Linda Hidy as Division Rep for the Western Division. She stayed as Division Rep through 2017; served as Monthly Tournament Chair from 2018-2019; Major Tournament Chair 2020-2021 and served as President from 2022-2023; and advisor in 2024-2025. They were each presented with a beautiful bouquet.

INTRODUCTION OF 2026 BOARD OF DIRECTORS WPLGASC: Lou Ann presented the 2026 Association Board elected previously in the meeting.
