2026 Team Roster Preparation

PLAYER HANDICAPS

GHIN Handicap Index on January 1, 2026 will be used by all players.

OPTIONS TO COMPLETE THE ROSTER FORM

(*preferred*) Enter information directly on the attached Team Roster Excel Form. Save and rename the completed form with your Club's team name (A or B). Return completed form in EXCEL FORMAT

(*only if necessary*) Print the Team Roster Excel Form and enter the info by hand.

ELIGIBILITY OF TEAM MEMBERS

Any WPLGASC Member of a WPLGASC Member Club who meets the following requirements is eligible.

1. Must be a member of the Team Play Club *and* be listed on the following two reports:
 - A. Dec 1, 2025 WPLGASC 2026 Club Membership Roster for the Club she chooses to play for.
 - B. Jan 1, 2026 USGA/SCGA Hcp Index Report for the WPLGASC Club she chooses to play for.
2. WPLGASC Membership Chair, Janet Herbold, must receive WPLGASC Individual Membership dues and Club Dues for each team member and Club by the December 1, 2025 membership deadline.
3. Players will join (pay WPLGASC dues) at *one* WPLGASC Club. The Club must be a WPLGASC Member Club for 2026. If a player belongs to several WPLGASC Clubs, the player may play for any one of the 2026 WPLGASC Member Clubs where she is a member.
4. Team Members must have a USGA/SCGA Hcp Index as of Jan 1, 2026 based on 20 scores. Three (3) of the 20 scores may be games played at any course, dated between Jan 1, 2025 and Dec 31, 2025.
5. A player may play on one Team for one Club only.

Captains, please verify the eligibility policies above for the members on your 2026 Team Rosters. If you have members whose handicap index may not be current, ask your Club Handicap Chair to check the handicap detail reports of those members for you.

WPLGASC reserves the right to refuse the entry of any member at any time with sufficient reason.

2026 USGA HANDICAP INDEX REQUIREMENTS

- **HANDICAPS FOR "A" TEAMS:** USGA Handicap Indexes - 0-22.0. A player with an index higher than 22.0 may play on the A Team, but must play down to a 22.0 index.
- **HANDICAPS FOR "B" TEAMS:** USGA Handicap Indexes - 18.0-36.0. Players with an index higher than 36.0 may play on the B Team, but must play down to a 36.0 index.

HANDICAP INDEX ORDER

If a club fields both A and B teams, the handicap indexes of the teams may not exceed each other. For example: if the index of the last player on your A team is 19.5, the first player on your B team may have an index of 19.5 or higher. The same applies in 2-Club Teams.

HOW TO COMPLETE YOUR ROSTER

The Official Roster is due by Wed Jan 24, 2026.

1. If completing by hand, Rosters must be completed in ink. Please print legibly. No cross outs, etc.
2. Please enter GHIN number, last name and first name as it appears on the January 1, 2026 USGA Handicap Index Report.
3. List your team members in handicap index order beginning with the lowest handicap index (lowest decimal number to highest decimal number).
4. Please enter contact information for both a Captain and an Asst Captain on the Roster. Each team must have an Asst Captain. Both must be members of the team they represent.
5. If completing by computer, save the form as the name of your club (i.e. Simi Hills A, Lakewood B) in ***Excel Format***. Attach that file to an email to Karen Kiddy, wplgateamplay@gmail.com **AND** Janet Herbold, wplgamembership@gmail.com.
6. By sending your Roster in Excel, necessary changes/corrections can be made without back-and-forth emails and attachments. You will be advised at the time if any changes are made, and you will receive a PDF copy of Validated Rosters in a subsequent emailing.
7. Email your completed Roster to **BOTH** Karen Kiddy and Janet Herbold. Janet will confirm the players on your Roster were WPLGASC Members on 12/1/2025. Karen will confirm other qualification criteria.
8. If completing by hand, print the form, scan and email or send by regular US mail to Karen Kiddy.

Please send your final Roster as soon as it is complete.

Must be received by Karen Kiddy and Janet Herbold no later than January 24, 2026.
