## **MAJOR TOURNAMENTS: Sherri Little**

- All Major Tournament contracts are completed and signed for 2026.
- Sherri is now in the process of working on the 2027 calendar.
- Kick Off Tournament on January 26, 2026.
  - 252 Members registered.
  - 148 were accepted.
  - 45 combined participation points to be accepted.
- Sherri received several emails from disappointed members who did not get in the tournament because of lack of points. Suggestions from members included:
  - An alternate course nearby for those on waitlist to play.
  - Waitlist players playing the day before at Rio Hondo.
  - Board members play in same foursomes.
  - Minimum points for board members and team members without automatic entry.

A discussion took place about the participation points that were required to gain acceptance into the tournament and that some of the board member groups were below that threshold.

Although this year's tournament cannot be changed as players have already been accepted into the tournament, there was discussion by the board on how to improve next year's Kick Off. Sherri Little made a motion that board and past presidents should play together, thus opening room for more member teams to be entered into the tournament. The motion was seconded by Lydia Salcido. The motion carried with 11 in favor and one against by show of hands.

## **MONTHLY TOURNAMENTS: Lydia Salcido**

- Lydia is finalizing the monthly Association Days for the website.
  - Delay is related to some of the 2026 courses on the Contract Information Sheet which do not have final contracts.
    - Lydia will be posting the courses without completed contracts as a 'to be determined' (TBD) on the website.
  - Delay is also related to playing tees are not indicated on Contract Information Sheet.

- All Association Day registration is to be done by mail with the only payment option being a check made out to WPLGASC. No ZELLE payments will be accepted at this time.
- Playing two WPLGASC Association Days in the same is week is acceptable with the following criteria:
  - Member playing additional day is substituting for a cancellation.
  - Members will only receive one participation point.
  - Members are eligible for awards at both events.
- Membership Courses
  - In some cases, when agreeable with the course, members having private memberships may not have to pay green fees.
  - Members do pay the \$5.00 registration fee.

### **TREASURER: Susan Shimizu**

- Balance Sheet and Profit/Loss Statement dated November 30, 2025, was provided at Annual Meeting.
  - FYE Financial Statement ending 12/31/2025 will be available later this month after year-end Journal Entries is completed.
  - Any member who would like a copy may contact Susan directly.
- Expense Reports
  - List of authorized expenses were distributed.
  - Quarterly submissions of Expense Reports to Susan were recommended.
- Statement of Information (Secretary of State), Fictitious Name Filing (State of California) have been filed for 2026.
- Conflict of Interest Statements
  - One is still outstanding.
- Chase Bank
  - Signers will need to provide signatures at their local Chase Branch, then Debit Cards for deposits will be issued. Team Play Chair will need one as well.
  - A new WPLGASC Credit line with an overall limit of \$66,000 was approved by Chase Bank on January 2. This line has no liability to individual Board Members as in past years. We will begin utilizing this Line of Credit as soon as cards are issued (expected) late next week. Authorized users are Donna, Sherri, Lydia, and Susan.
