#### STAFF/COMMITTEE REPORT HIGHLIGHTS:

#### Commandant: (Verbal)

- ➤ Jason attended National Convention in Texas and has attended a couple detachment meetings, stated all detachments need to check National Website for updated By-Law and AP changes that were voted on at NC.
- Marines and Associates doing an AWESOME job!! If they rate recognition at Detachment level or above, award them appropriately.
- Look at developing a mentor type program at your detachment for new members.
- Anyone desiring to hold an office whether Detachment level or above, please educate yourself on position and responsibilities, create effective turnovers within the positions for success.

<u>Sr Vice</u>: (On File, Verbal): Reiterated about significance of awards for members. Finds lots of members doing hard work with minimal recognition. Send Sr. Vice an email with write-up if you want awards to be elevated to Department or National.

<u>Jr Vice</u>: (Verbal): Tried to reach out to all Jr. Vice's at Detachments, 5 emails came back. Please make sure I/we have correct email addresses on our department rosters, and ROIs are correct.

#### Judge Advocate (Verbal):

- Originally stated had 4/18 Detachment By-Laws endorsed so far. This was later corrected that Judge Advocate had endorsed or had on file 14/18 Detachment By-Laws.
- ➤ Pen Change, Section 200 paragraph D, scratch "men" and put all. National Section 900 is no longer required to be completed by certified mail, can now be completed via email or zoom.
- ➤ All NVC's/ANVC's must reside somewhere in the Region they represent.
- ➤ Uniforms, you can no longer wear earrings male or females. Earring cannot go past lobe. These issues may have to be addressed when membership comes up, be careful on how addressed.

In January, JA will have clarification on Medallions and Collars, and Mike Francis pointed out to JA to include clarification that the MCL cannot dictate the wearing of the Chaplains of Four Chaplains Medallion.

# Adjutant (Verbal):

- ➤ Introduction as Adjutant, OUTSTANDING JOB on report submission 15/18!! I sent out an email with multiple attachments as examples regarding tracking for both Department and MWDNVC requirements.
- Quarterly report, just get report to me, I'll worry about getting info in correct Department format for quarterly meeting.
- All information sent by me will be sent to Detachment Commandant and the Adjutant moving forward. Try and scan PDFs into one complete document.
- ➤ I will read all reports, please provide dates on Secretary of State/ 990's etc. Please pay attention to detachment meeting attendance and make sure you are meeting Quorum based on your By-Laws.
- When you are addressing hours completed per quarter, please make sure all hours include preparation, planning, rehearsals, travel to and from, phone calls, emails, and so on.

## Paymaster (On File, Verbal):

- ➤ I am tracking transmittals since Convention, if no reply from National please contact Jim. As of 09.26.2025 (155) renewals regular members, (19) new regular members, (28 renew associate members, (24) new associate members, (4) renew dual members, (4) life members \$1000, (3) NOD's.
- Major changes for transmittals, NO REQ for transmittal in NOD cases, however, still needs to go up chain on both sides. Submit and copy the following individuals (JD Foster, Teresa Terry, Howard Schaffer, Jim Maevers, and Fred Romain).
- If submitting multiple page transmittals put ALL totals on TOP PAGE. For all Commandants and Paymasters, by now you should have access to the Data Base Portal, if not contact Jim.
- Access based on correct email info on ROI, cannot be personal email address. Both of you can print detachment rosters or change addresses or contact information on members.
- ➤ In Data Base remember to switch from Personal Profile to Detachment Profile. PLM Audit deadline is December 31<sup>st</sup>, currently submitted PLM's are Detachments 656, 725, 1137, 1214, 1495. Should have received audit in July. These must be signed by Commandant and Paymaster, and make sure these are **DATED**. If a member passes after June 30<sup>th</sup>, should not affect your PLM for previous
- ➤ GREAT JOB on submission of 990's, when these are completed, please ensure Jim gets 1<sup>st</sup> page to verify completion whether Long Form or Post Card.
- ➤ Secretary of State Registrations DUE NOW! Recommended by paymaster to submit Secretary of State Annual Report (annually) even though option exists for 2-year submission, depending on odd/even year. One mistake can create a potential civil case if all paperwork is not aligned with ROI.
- ➤ SOS registrations, currently see completed is Department of MO, 1393, 1081, this information is part of a Compliance Report.

# **MCL Foundation** (ED):

- > <u>TELL THE STORY</u> of the Foundation. Only 25 % of our Marines know about the MCL foundation.
- Marines believe if they contribute to MCL Heritage Foundation, funds being received by MCL FOUNDATION (not true)
- If you want \$\$\$ to go to directly to MCL Foundation you must donate directly to them not some other umbrella.
- MCL Foundation dispersed out \$134,350 last year, only received \$30 K in donations, .75 cents per member.
- What are we trying to do to fix lack of knowledge, and donation issues: we have created an annual budget submission for approval at National Midwinter Convention, trifolds, coin fund raiser etc.
- ➤ General Gray coins gone. Has some 250-year coins and they are numbered, will auction # 500 at the MWD conference.
- At the National Convention the MCL foundation received in **one hour** more donations than the whole previous year!
- Sending an individual to (3) day Grant Writing Course.
- Follow instructions and understand requirements. If application not completed correctly, it will be rejected.

# MIDWEST DIVISION NATIONAL VICE COMMANDANT (Jim Maevers)

- At National Convention on Sunday Board of Trustees Meeting they get a brief from Morgan Stanley, the PLM fund for FY has grown to just over \$8M dollars. Accounts doing extremely well.
- > Potential to purchase a portion of building verses leasing it.
- NVC wants to reiterate the Chapel of Chaplains, at National they gave a great brief on history and so on.
- > CEO/COO Bob Borka received the Legion of Honor Award
- Budget Committee brief recommended and approved (1) change, currently as of 22 July 2025, total league membership is 53,033 with 33, 388 of this being life members, this equals 63 %
  - From this no annual dues are generated, committee recommended taking a portion of the PLM fund approximately \$655k and using it to create an endowment level to cover costs and benefits afforded to life members. Minimal impact since the PLM fund is on track to grow about \$1M per year on current path.
- VSO's- (MCL wide)- currently we have (21) Accredited, (6) VSOs at Division level, and (13) in training and in processing. National hired new VSO Training officer Philip ?????

- South Dakota detachment Jesse Kildespire gave great presentation on Veteran Grave Site Mapping he's been working on, you can use your smart phone to ID veterans at all public cemeteries.
- Newsletter Awards- Simpson-Hoggat, Detachment 984, 2<sup>nd</sup> Place Company level and South St. Louis, detachment 183, 3<sup>rd</sup> Place Battalion Size- Great job! If you have newsletters submit them for awards
- Thursday of convention was National Officer Nominations- National Commandant- TJ Morgan, Sr. Vice- Russ Miller, Jr. Vice- Dave Porter, and JA- Bruce Rakfeldt- All nominees were uncontested and elected by Acclamation on Friday during the Business meeting
- NVC and others trying to determine what happens to National Reports once the convention is over, these need to be archived so leadership can locate them, while convention going download PDF.
- Great Grand Ball- 1 MEF Commander was GOH, MOY was Past National Commandant Johnny Baker, and AOY was Mario
- MOMARINES has all conferences listed for DEPT, DIV and National for 2026
- Activity Log tracking- its important, NVC will help manage from MACRO Level, will depend on Department Adjutants to manage at MICRO level working with Detachments and feed info to him. Purpose to build credence and solidifies brief to the MC and what we are doing.
- NVC likes what M4L is doing. NCV was invited and attended a zoom meeting with Midwest Region representative skip Crowley. We need to be more involved with M4L Program. Each detachment needs to have a designated M4L Rep, if no one is designated then the Detachment Commandant will be the POC.
- Focus Marines, NVC has a flyer for Raffle, all proceeds will go to Focus Marines, Jim will put flyer on the MOMARINES Site.
- NVC agrees with ED, on consistent support of the MCLF.
- If you get a chance check out Andrew Cox PODCAST. LOSTART Project with Veterans. Matt Anders and few other have been on the PODCAST. Check it out.
- Finally: Ponder what your idea detachment would look like: AGE, Activities, community support, etc.... we all have perceptions and ideas.

#### **UNFINISIHED BUSINESS:**

- Commandant stated that Department still needs nominees of detachments willing to host the 2026 Department Convention. Lots of major events going on from Kansas City to St. Louis (world Cup and LPGA)
  - o May have to be Ozark or South region that takes it on
  - Any detachment can host, and you can host at any location even if not in your detachment area
  - Suggestion made that may have to change from Department Convention to Quarterly meeting, or maybe it's a one-day verse 3-day event.
  - Need nominations for potential host by 30 October 2025.
- Central MO Detachment 656 will be hosting 250<sup>th</sup> Marine Corps Birthday Capitol Cake Cutting, one hour event, followed by social that evening. They are working the many details; potential cost will be between \$2K and \$3100.
  - Donations to help cover cost are welcome from detachments to department.
  - After much discussion motion was made by Jim Maevers to all him to write a check from Department of MO directly to Detachment 656 for \$3000, motion was seconded by Mike Francis, no further discussion, motion carried and any \$\$ left or above total cost will be returned to the Department of MO Paymaster and over-all finances will be briefed by 656 at the January, quarterly meeting, along with submission of all receipts and so forth.

## **NEW BUSINESS:**

- MOTION: Jim Maevers (Paymaster) made a motion to reimburse Department Commandant for his attendance/expenses at the National Convention. Totals were as follows: Air Travel \$204.95 (+) Hotel \$1011.25=\$1216.20, motion was seconded by Frank Livingston, no further discussion motion carried.
