- 1. Welcome and Call to Order: Marissa established a quorum and called the meeting to order at 7:03PM (A quorum was present with 6 of 7 Board members in attendance.)
- 2. Approval of Agenda: Agenda was approved as distributed by consensus.

- c. <u>Dam Project Funding:</u> Andy has a new contact with King County that is dedicated to our project. She is helping us with several Grant applications.
 - i. One of the grants will require a seismic study in order to apply. The next step is getting the OK from the Dam Safety Office to extend our timeline so we can hopefully get help with funding from a Grant via King County.
 - ii. We discussed how to communicate the possible need for additional Dam project funding with the community. We will plan to issue some sort of newsletter with the annual notice this year.
- d. <u>Beaver Dam</u>: Kacie met with Kevin from Fish and Wildlife. The meeting was productive and there is paperwork in place in motion to handle the Dam.
- e. <u>Fish Stocking & Park Improvements</u>: We discussed the possibility of some general improvements at the park and quotes for the following are being pursued to discuss at our next meeting: Sand for the beach, Fish to Stock the Lake, A bench to add to the trail, A new picnic table to replace the one closest to the lake.
