Terms of Rental

- 1. <u>Rental Period</u>: The rental period shall commence on the date listed in "Rental Start Date" and terminate on date listed in 'Rental End Date". The Lessee shall return the equipment to the Owner's premises by the end of the rental period in the same condition as it was received, ordinary wear and tear excepted.
- 2. <u>Rental Fee</u>: The Lessee shall pay a rental fee listed in "Daily Rate" per day of the rental period. The rental fee is due in full upon the signing of this Contract and is non-refundable.
- 3. <u>Security Deposit</u>: The Lessee shall provide a security deposit of \$100 upon signing this Contract. The security deposit will be refunded to the Lessee within 10 business days after the end of the rental period, provided that the equipment is returned in good condition.
- 4. <u>Use of Equipment</u>: The Lessee agrees to use the equipment solely for its intended purpose and in accordance with all applicable laws and regulations. The Lessee shall not make any alterations or modifications to the equipment without the Owner's prior written consent.
- 5. <u>Maintenance and Repairs</u>: Damages made during rental period will be charged as listed in "Fee List" and are due in full within 5 business days of 'Rental End Date".
- 6. <u>Insurance</u>: The Lessee shall maintain adequate insurance coverage for the equipment during the rental period, including coverage for loss, damage, and liability. The Lessee shall provide proof of insurance upon request.
- 7. <u>Indemnification</u>: The Lessee shall indemnify and hold harmless the Owner from any and all claims, damages, losses, or liabilities arising out of the Lessee's use or misuse of the equipment.
- 8. <u>Termination</u>: The Owner reserves the right to terminate this Contract at any time if the Lessee fails to comply with any of its terms and conditions. In the event of termination, the Lessee shall immediately return the equipment to the Owner.
- 9. <u>Governing Law</u>: This Contract shall be governed by and construed in accordance with the laws of Duval County, the state of Florida, and/or the United States of America.
- 10. <u>Entire Agreement</u>: This Contract constitutes the entire agreement between the parties with respect to the rental of the equipment and supersedes all prior agreements and understandings, whether written or oral.

Fee List

- 1. **Lost Lock/Key**: In the event that the Lessee loses the lock or key to the trailer lock, a fee of \$50.00 will be charged to cover the cost of replacing the lock and cutting it off the trailer.
- 2. *Excessive Cleaning*: The Lessee is responsible for returning the trailer in a clean condition. If the trailer requires excessive cleaning beyond normal wear and tear, a cleaning fee of \$100.00 will be charged.
- 3. **Damaged Jackstand**: In the event that the Lessee damages the trailer jack beyond normal wear and tear, the Lessee shall be responsible for jack replacement fee of \$75.00.
- 4. **Damaged Boards**: In the event that the Lessee damages the wooden floor board(s) beyond normal wear and tear, the Lessee shall be responsible for board replacement fee of \$20.00 per board plus labor costs.
- 5. *Tire Damage*: In the event that the Lessee damages the trailer tire(s) beyond normal wear and tear, the Lessee shall be responsible for tire replacement fee of \$50.00 per tire plus labor costs.
- 5. *Light Damage*: In the event that the Lessee damages the trailer light(s) beyond normal wear and tear, the Lessee shall be responsible for light replacement fee of \$50.00 plus labor costs.
- 6. **Other Damage**: The Lessee shall be responsible for any damage to the trailer beyond normal wear and tear. Repair costs will be assessed based on the extent of damage and will be charged to the Lessee accordingly.
- 7. *Late Return*: If the Lessee fails to return the trailer by the agreed-upon return date and time, a late fee of \$250.00 per day will be charged until the trailer is returned.
- 8. *Unauthorized Use*: If the Lessee uses the trailer for any unauthorized purpose or in violation of this Contract, additional fees may be imposed at the discretion of the Owner.
- 9. *Towing and Recovery*: If the trailer becomes inoperable due to the Lessee's negligence or misuse and requires towing or recovery, the Lessee will be responsible for all associated costs.
- 10. *Insurance Deductible*: In the event of damage covered by insurance, the Lessee will be responsible for the insurance deductible as outlined in the insurance policy.
