Physical Transfer of Care and Fees

I, _____ understand that I am responsible for transporting, or arranging transport of, the Equine to Sky Ranch Idaho unless other arrangements have been agreed upon in advance with Sky Ranch Idaho. I acknowledge that Sky Ranch Idaho does not charge a surrender fee for horses, however donations are always appreciated and go directly toward animal care.

Surrender Rights

By executing this document, I, _____ understand that I am giving up all right, title, interest, and possession of the Equine (regardless of the delivery or non-delivery of registration papers) voluntarily and without coercion or threats of any kind and without reliance on any representations, guarantees, or warranties of any kind from anyone, whether verbal or written. I further understand that all future decisions regarding the care, treatment, and placement of the Equine will be at the sole discretion of Sky Ranch Idaho and I have no right of first refusal for the return of the Equine. I acknowledge that after surrendering the Equine, Sky Ranch Idaho is under no obligation to share or provide information about the Equine. I further agree and understand that Sky Ranch Idaho will evaluate the Equine to determine whether the animal will be considered for placement in an approved home, live as a resident at Sky Ranch Idaho or, if deemed necessary by a veterinarian, humanely euthanized. I

understand that Sky Ranch Idaho does not euthanize due to time or space constraints. Sky Ranch Idaho is committed to the preservation of life of all our animals within reasonable means and considers euthanasia only for animals who are determined by a licensed veterinarian to be suffering mentally and/or physically with no available course of care, terminally ill, or considered untrainable and eminently dangerous to themselves, other animals, and/or humans beyond a reasonable doubt. Lastly, I agree to hold Sky Ranch Idaho and all of its officers, directors, employees, contractors, insurers, transferees, successors, and volunteers harmless now or in the future from any claims of damage, injury, or acts of negligence or other wrongdoing arising from or relating to the surrender of the Equine.

By signing below, I certify that I have read and understand the terms of this Agreement, understand and agree that I have alternative equine adoption facilities to choose from and voluntarily agree to surrender and relinquish the Equine to Sky Ranch Idaho and be bound by all of the terms and conditions contained in this Agreement.

(c) Entire Agreement. This Agreement constitutes the entire agreement for my surrender of the Equine supersedes any prior agreement or understandings by HWH.

(d) Waiver. No waiver of any breach or condition of this Agreement by HWH shall be deemed to be a waiver of any subsequent breach or condition of a like or different nature.

(e) Binding Effect. This Agreement and all the terms and provisions hereof shall be binding upon, and shall inure to the benefit of, myself as well as my heirs, beneficiaries, personal representatives, successors, agents and permitted assigns.

(f) Captions. Captions contained in this Agreement are inserted only as a matter of convenience and no way define, limit or extend the scope or intent of this Agreement or any provision hereof.

(g) Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois and I agree and consent to the jurisdiction of the State of Illinois for this purpose.
