NOVEMBER SPEAKER—KEN FROST

A native of San Francisco, Ken moved to Marin with his family in 1947. He earned a PhD in chemistry at UC-Davis and then worked for Chevron for 34 years. He joined the teaching staff at Dominican University in 2005, where he ultimately became involved with environmental chemistry, biofuels, and the work of the Marin Carbon Project and the Carbon Cycle Institute.

Ken says: After reviewing the science of climate change, I believe things are changing for the better. The growth of wind and solar energy as alternatives to conventional electric power generation is starting to have an impact. The electric vehicle and the hybrid are improving the traditional fuel economy and lowering the carbon dioxide emissions associated with driving our cars. These important changes are reducing the overall amount of carbon dioxide emissions.

Perhaps even more exciting is the potential impact of the work originally done by the Marin Carbon Project led by John Wick and funded in part by the Rathmann Family Trust.
