Morning workshops

How do we demonstrate the role and purpose of local infrastructure to an incoming government?

Join Jill Hopkinson, Policy Manager at NAVCA, to identify core messages and priorities for an incoming government, such as the contribution of local infrastructure to thriving communities and tackling inequalities, and how to demonstrate this.

How do we demonstrate visible leadership when tackling racism?

Join Hannah Olarewaju from Diversity Marketplace to explore what we need to do to show leadership in anti-racism, as well as what we need to do to empower people and create space for diverse leadership in the voluntary sector.

How do we strengthen collaboration in VCSE healthcare commissioning?

Join Angela Ellis Paine, Lecturer in Voluntary Sector Management at City University, to explore and share learning from research, policy and practice, to strengthen VCSE and health and care commissioning.

How can we develop a local vision for volunteering?

Join Becky Isaac, Vision for Volunteering Implementation Manager at NAVCA member Birmingham VSC, to explore their process of consultation and coproduction in developing a local vision for volunteering for Birmingham.











Afternoon workshops

How can we have effective influence on decision-making locally?

Join Maddy Desforges, CEO at NAVCA, to share your learning and experiences around approaches needed for local leadership in the current context, and what barriers exist to convening at place. This session is recommended for CEOs and senior leaders.

How can we achieve racial and climate justice in the charity sector?

Join Mahnoor Kamran, climate justice advocate and youth Board member at Good Energy, to explore the importance of racial equality in relation to the climate emergency, and how the voluntary sector can make a positive difference in this space.

How can we make funding opportunities more fair and transparent?

Join Helen Betts and Scott Copeland from NAVCA member Nova Wakefield District to explore their local funding partnership, the Third Sector Framework, which aims to make funding for local VCSE organisations more open, fair and transparent.

How do we meaningfully engage young people in volunteering?

Join George Fielding, Policy and Public Affairs Officer at Volunteering Matters, and leading iwill Ambassadors to explore how young people might experience volunteering differently, and how to harness their enthusiasm for making positive change.

Join a team from the National Cyber Security Centre (NCSC) to explore how local infrastructure organisations can make the most of AI, whilst also protecting themselves and other charities against the potential risks.

Walking: Austin Court is a 15-20 minute walk from Birmingham New Street Station. You will pass the Library of Birmingham and the The International Convention Centre on your way. The venue is near the Birmingham Canal.



Public transport: If you arrive into Birmingham New Street, you can take the metro from Grand Central to Library, then walk for 5 minutes to Austin Court. You can also take the 12, 12A, 13, 9 Platinum or X8 Platinum buses.



Driving: If you need a parking space at the venue for accessibility reasons, please enquire about this when booking your ticket.
