Introduction

This Cookie Policy explains how Tekserv Contracting ("we", "us", "our") uses cookies and similar technologies on our website www.tekservcontracting.com.au (the "Site"). By using our Site, you consent to our use of cookies in accordance with this policy.

1. What Are Cookies?
