

## **HOMESTEAD TAX REFUND 2014**

\*FYI: THE FOOD SALES TAX REFUND AS WELL AS THE HOMESTEAD RENTAL REFUND HAVE BEEN DISCONTINUED. THE HOMESTEAD TAX REFUND IS NOW ONLY AVAILABLE TO HOME OWNERS.\*

THE EAST CENTRAL KANSAS AGING AND DISABILITY RESOURCE CENTER WILL BE PROVIDING HOMESTEAD TAX REFUND PREPARATION SERVICES AGAIN THIS YEAR.

TO RECEIVE THE PREPARATION ASSISTANCE, YOU MUST:

- 1. Live in Anderson, Coffey, Franklin, Linn, Miami or Osage County
- 2. Be age 60 or over
- 3. Complete the 2014 Homestead Information Form, as well as provide **copies** of all required documents by **April 1**. Note: we will **not** be returning any documents sent to us, so please send **copies**, **not originals**.



## TO QUALIFY FOR THE HOMESTEAD REFUND YOU MUST:

- 1. Have been a resident of Kansas all of 2014
- 2. Must have total household income of \$33,400 or less.
- 3. Have been born before January 1, 1959
- 4. Be a homeowner, non-delinquent property taxes, & reside in the home.
