## Hi Tracy:

The Hall Street WWTP conducted toxicity testing on January 2-3. We have been informed verbally of the preliminary results that the facility failed its toxicity analysis. I will provide official notification once I receive the final written report. Our permit requires a 1 week resample period once we receive our results. We would like to request an extension of the 1 week deadline in order for us to make some changes prior to resampling. More specifically we believe that the high ammonia concentration is causing the toxicity failures. We would like to suspend our leachate

disposal program for a one week period prior to retesting to evaluate the effect of leachate on the systems effluent ammonia concentration. As this will put a strain on our leachate clients we would like to give them a couple of weeks' notice before shutting them down for the one week period. I anticipate we can schedule the leachate shutdown and collect our toxicity sample no later than February 28. Thank you for your consideration.
