Response to NH DES Facility Inspection and Deficiency Report – 11/2/2022

Dear Mr. Mills,

North Country Environmental Services (NCES) writes to provide a response to the November 2, 2022, inspection report for the NCES Landfill Facility located in Bethlehem, New Hampshire. We have reiterated these items listed in your electronic mail notification and provide our response in **bold** print.

1. Env-Sw 806.03 (c)

Requirement: At landfills receiving MSW, cover material shall be placed over all exposed waste no less frequently than at the end of each operating day.

Observation: NHDES Inspectors arrived at the facility at approximately 5:30AM on 11/2/2022 to conduct a limited facility inspection. The facility gate was closed and there was no indication of activity on site. The first operator opened the gate at approximately 5:40AM and NHDES inspectors entered the facility. At approximately 5:50AM, Bruce Grover and Kevin Roy, both of Casella, met with NHDES inspectors who were then escorted to the working face to view the application of daily cover from the day before. Upon arrival to the working face, geosynthetic tarps, natural soils and other alternate daily cover types were observed to be covering the majority of waste with some waste flagging issues seen. There were 3 areas of concern observed to contain uncovered wastes:

Area #1: Downslope from the termination of geosynthetic tarp coverage, there were small berms of primarily intermediate cover material containing intermixed wastes observed. These berms were beyond the reach of the geosynthetic tarping used as daily cover and did not appear to be covered otherwise. The wastes appeared to have been uncovered and mixed with intermediate cover during prior cover stripping operation in order to conduct subsequent lifts. The berms were intermittent in nature and did not span the whole width of the active area.

Area #2: There was a single gap in the geosynthetic tarping system measuring approximately 3 feet by 10 feet. No cover material was observed to be applied to this waste.

Area #3: The tipping area from the day before was discovered to contain some small areas of waste not exhibiting application of cover material.

NCES collected photographs of daily and intermediate cover applied at the end of each day from November 2, 2022 through November 11, 2022. The photographs were emailed to you as verification

that acceptable levels of daily cover is being applied by the facility. Based on the email received from you to the NCES Landfill General Manager (dated November 14, 2022) the photos provided confirmation of compliance for deficiencies identified in the November 2, 2022 inspection and deficiency report.
