Hello Kyle.

Thanks for getting the parties together regarding the Collins and Aikman Plant (former) Superfund Site (the "Site") and the potential for its beneficial reuse. Though one of the important goals of any cleanup at a Superfund Site is

to return the property to beneficial use, at this time EPA and NHDES agree that any proposal to further subdivide the Site property for sale or lease, and development, would need to wait until at least a remedial alternative is selected, designed and implemented. Until that time, it is not known how the implementation of a remedial alternative may impact the property, what access requirements there may be, and what restrictions may be put in place.

EPA's remedial investigation of the Site is complete and the nature and extent of contamination has been characterized. As you mentioned, EPA's release of the proposed plan for a preferred remedial alternative is scheduled for this year. At this point we are planning to release the proposed plan in May/June with a 30-day public comment period running in to July/August. Following release of the proposed plan, EPA and NHDES will convene a public meeting to present the proposed remedial alternative and hold a hearing for public comments. We will be contacting the Town soon to plan for the release of the proposed plan and a public meeting and hearing.

I do not believe our system can keep up with this demand. In the summer when our usage is at its highest, we are pumping 300,500 gallons a day in the winter; it drops to 200,000 a day. Also a question? where would the wastewater go since there's no way currently to take PFAS out of the water system? Also keep in mind our wells have currently have non detectable levels of PFAS in them today which is very rare in the state of NH today.

Yesterday, Ken and I met with several folks from Northeast Purification Systems to discuss the potential for several new and innovative industries coming to Farmington. One of those was the PFAS Annihilator, which according to their website is a ready-now, destruction solution powered by supercritical water oxidation (SCWO). This technology breaks the nearly indestructible carbon fluorine bond, destroying PFAS chemicals in Aqueous Film Forming Foam (AFFF), landfill leachate, and wastewater to non-detectable levels. GAC Renew enables on-site regeneration of granular activated carbon (GAC) – extending its lifespan, minimizing downtime, and reducing the total cost of ownership.

It is my understanding that this facility would treat PFAS and then send roughly 100,000 -200,000 gallons per day of PFAS removed leachate to a WWTF. Obviously, the first question that came up was - does the Town's facility even have that capacity? And even if it did, how much capacity would be left? Is that enough to handle additional residential and commercial growth? In addition to determining if there is a suitable location within the Commercial/Industrial District that provides access to the municipal sewer system, there are a lot of other questions that would need to be answered prior to the Town entertaining a proposal such as this - i.e., Is there enough money that would be generated to make what I would imagine to be significant and necessary upgrades to the Town's facility? Please see below a few notes and some thoughts on next steps:

- To ensure we are all on the same page in terms of the property that has been identified for sale, please find attached two versions of maps that identify the property lines of the property.
- Josh, we really appreciate your willingness to share the background information you have on the property. We would be grateful for any information you can provide, including anything on the ownership history and the current ownership status.
- I will be working with the NHDES team to do a proper file review of any documents relating to the property. We fully intend to engage a consultant to produce a Phase 1 assessment, but we would like to begin the file review process as we do our prep-work for the permitting process and any other requirements for our proposal.

- Our team is in the process of conducting a survey of the property. This initial survey will not include any digging for testing of the soil, but we will be doing some overhead and topical survey work. Again, we understand the importance and need to work with NHDES to develop a plan for doing soil testing to gather the data needed by all parties for the permitting process including the development of a remedial action plan, and we plan to work with NHDES on the timing and methods used for that testing work.
- This survey work will allow us to produce an initial design concept along with a proposal concept overview white paper so we have something on paper to discuss.

Thanks again to all of you, we look forward to continuing the discussion on the proposal we are developing for our concept in a collaborative and transparent way. We want to ensure we meet all federal, state, and local permitting and any other requirements to move forward with the type of facility we are proposing, and the information and guidance provided by NHDES and the AG's Office during that process will be essential to achieving that goal.

They accept some materials that other facilities do not, but WL French's concern is opening the company up to future liabilities if any of the facility's acceptance list or operating procedures are not in full good standing.

Mr. Everton – NH does not have any such facilities, but there is a permit exemption for handling inert materials, with some provisions.

Env-Sw 302.03 Solid Waste Permit Exemptions

- (9) Collect, store, transfer, process, treat, or dispose of waste concrete, cement, brick, other inert masonry materials, or bituminous concrete, provided that:
  - a. The waste is actively managed;
  - b. Management practices comply with the universal facility requirements in Env-Sw 1000;
  - c. The materials comprising the waste are derived from virgin materials only;
  - d. The materials comprising the waste are fully cured;
- e. The waste is free of any materials or substances that have the potential to leach contaminants to groundwater or surface water or to emit pollutants to the air, including lead

paint, asbestos, and chemicals;

- f. If landfilled, the bituminous concrete waste is not ground or pulverized; and
- g. The activity occurs after March 30, 1999;
