SUMMARY OF CONVERSATION

Called Olson in ref. to application for minor modification of solid waste facility, permits now held by Consumat-Sanco, Inc (CSI), as rec. to allow acquisition of all CSI stock by NEWS. Ref. WMD Log # 036-93, rec'd 03.31.93. Discussed the following:

1. Requested date of permit mod. is not given in the application as a "firm" date. Asked Olson if we could assume the transaction would NOT be scheduled until after the permit mod. process was completed. Olson so confirmed.
2. Re: financial assurance in they are proposing to maintain status quo? Olson stated "yes", but would await further instruction from agency. He Because NEWS plans to acquire all of what CSI owns, and at present CSI's only financial assurance provisions are the trust funds to town, the permit mod. application does not represent other than what exists / what is currently available for purchase.
3. Instructed Olson to submit Business Concern / Personal History Disclosure forms a.s.a.p. to NHDOJ / OAG.
