**Subject:** RE: [External] Upcoming Meeting

Peter ,

We brought in 27 loads 211,849 Gallons this weekend. I cant tell you enough how much we appreciated the help. All of our Secondaries are now back in compliance and 2 of our 3 cells are now cycling on and off . We look to be in full compliance by mid-week hopefully . We also installed 4 plus acre of 10 mil plastic in our new cell and diverted ½ of rain Sunday or 60,000 gals . We will be sending you the report soon if you haven't seen them already and we look to haul to you again this coming weekend. But not even close to the same volume. As requested here is our Leachate generation and disposal situation:

1. Site typically generates 8-9 million gals per year
2. Daily we generate 70,000 to 90,000 Gals per day ( 8-10 loads typically keeps us good ) that's 5 days hauling no weekends
3. We typically don't have weekend disposal so we are full come Monday
4. Weather Events construction , filling sequencing all increase generation
5. Current this spring we had a new 5 acre cell wide open and we was filling on a side slope . Both created more Generation
6. WE have over 30 inches of snow and 6 inches of rain in the last 6 weeks.
7. WE are capping that side slope this year ( 6 acres ) which will cut off all generation in that area. Also installed scrim in new cell as mentioned
8. We have an above ground AST 150,000 gals and 2 in ground 30,000 gal tanks.
9. There is storage capacity in all three cells but we have a 7 day limit not to be over 12 inches
10. Our main Disposal WAS Concord NH ...it was unlimited . It is now 2 loads a day however we take Coventry's 2 loads ..so 4 loads a day to Concord No weekend
11. Franklin takes 3 loads per day and they have giving us 3 loads on Saturday for a while now
12. We have temporary access to Manchester 3 loads per day no weekends .  
Ends May 13<sup>th</sup>
13. We now have access to Allenstown 3 loads per day and they did give us 3 loads this past Saturday . New permit 189,000 per month
14. We have access to Plattsburgh however Coventry limits them out
15. We have access to Montpelier but need to have PFAS Treatment

16. WE also have access to Essex Junction Burlington, and Barre Vermont but very very small quantities and PFAS could be issues with all for all fo them

SO current total daily disposal access : 3 Franklin,3 Manchester, 3 Allenstown, and 4 Concord. Total 13 per day during week days

3 Franklin and 3 Allenstown on weekends

We are also operating on an Emergency basis with the DES until May 6 at which time we are limited to 6 to 6 on week days and 6-noon on Saturdays. So three day weekends , holidays, weather events ...any day we can't haul leachate has the tendency to backs us up including a normal 2 day weekend.

We really could use a weekend outlet after we get caught up as we will be going back to normal hauling hours AND loosing Manchester as an outlet. It would be very helpful to not have to start every week in the hole
