The Hall Street wastewater facility is continuing to experience high ammonia concentration in the effluent water being discharged to the Merrimack River. For proper facility operations we are attempting to maintain an effluent ammonia concentration below 18 ppm. For the past few weeks we have experiencing an effluent ammonia concentration of approximately 30 ppm. As leachate has been Identified as the major contributor of ammonia to the plant we will be further reducing the daily trucking/disposal limit to 2 truck per day for each facility starting April 1, 2024. Please let me know if you have any questions regarding this change.
