Pursuant to 485-A:17, II-b(a), Granite State Landfill, LLC (GSL) is requesting an extension for 90 additional days to respond to the request for more information (RFMI) from the AoT program dated June 24, 2024. This request will extend the response deadline to June 21, 2025. There are three principal reasons we are seeking this extension. The first is that the adoption of the new Env-Sw 800 rules has required us to reevaluate all of GSL's pending applications for consistency with the requirements of the new rules. The second is that GSL has had to engage in discussions with and educate the owner of the parcels outside of the two landfill parcels about why DES is requiring GSL to access his parcels. These discussions were successful, and GSL has been able to complete the sitework required by AoT's RFMI, but GSL is still aggregating the data and preparing the responses to the RFMI. The third is that the RFMI has resulted in design adjustments to proposed stormwater infrastructure, and that design work is not yet completed.

A similar request will be made to NHDES-wetlands to extend that response deadline as well.

As discussed , Granite State Landfill, LLC (GSL) is requesting a second extension for 60 additional days to respond to the request for more information (RFMI) dated June 24, 2024. This request will extend the response deadline to March 23, 2025 and is made to provide additional time to respond to the items in the letter, some of which require design adjustments to proposed stormwater infrastructure. Field work required to respond to the RFMI is ongoing and taking longer than anticipated, including infiltration testing and seasonal high-water table delineation.
