On February 28, 2021 I became aware of a report of criminal threatening. Ofc. Donahue took the initial statement. The reporting individual,

Swan, Jon

came to the Littleton Police Department to report that,

Ingerson, Douglas

drove past him while in the Shaw's Parking Lot. While driving past Swan, it was reported that Ingerson threatened him by stating, "Your day is coming." or words to that effect. At the same time, Swan stated that Ingerson ran his finger across his throat. Ofc. Donahue took the initial report. I agreed to assist him in this investigation.

Ofc. Donahue's report, the video that Swan recorded, and Swan's statement are contained with the case investigation file.

On March 1, 2021, I reviewed the statement and videos that Swan provided to Ofc. Donahue. In the written statement, Swan stated that he had video recorded the encounter with Ingerson.

I reviewed the statement written by Swan. I did not speak with Swan directly because Ofc. Donahue had already interviewed him about this incident. Swan opened his statement by providing some information concerning the Forest Lake Landfill Development in which Swan described as being, "very heated and controversial." He identified Ingerson as the selling landowner. Swan also stated, "There is a lot of money at stake for both parties, just as much at stake for those who oppose it (the Landfill) as we will be negatively impacted should this development be permitted to exist." Swan also stated in his statement that he has had people tell him that they would not be surprised if Swan turned up dead someday.

In Swan's written statement, he wrote that he was on Meadow Street on February 28, 2021 when he observed Ingerson's dump truck behind him. He said he was waiting to turn left from Meadow Street to the access road to Wal-Mart when Ingerson passed him on the right. Swan wrote that Ingerson was so close that he believed Ingerson was going to side-swipe him.

I reviewed the video recording of this encounter. This recording was of Ingerson passing Swan on the right while Swan was waiting at the traffic lights to turn left from Meadow Street to the Wal-Mart/Shaw's access road. The video recording clearly showed Ingerson drive past Swan, but it is unclear how close Ingerson was to Swan. In the video, Swan was heard saying that Ingerson got close to him.

In the written statement Swan reported that Ingerson had driven down the shipping entrance to Shaw's and was parked across from Swan in the Shaw's parking lot. Swan said he believed that Ingerson had intended to interact with him, so he turned the video recorder function to his phone on. Swan reported that Ingerson drove past him and stated, "Your day is coming." According to Swan he observed Ingerson in his mirror smile and run his finger across his throat. Swan said he perceived this as a threat.

I was able to review the video for that interaction. I observed Ingerson's vehicle drive past. I was able to hear Ingerson say, "Your day is coming." The video did not capture Ingerson moving his finger across his throat.

On March 10, 2021 at approximately 2:00PM, I contacted,

Ingerson, Douglas

regarding the Criminal Threatening case involving,

Swan, Jon

I asked Ingerson if he would be willing to meet with me. I explained to him that Swan had filed a complaint against him. Ingerson informed me there had been an ongoing issue between Swan, Casella Waste Management and him. Ingerson stated that he would be willing to speak with me. I asked him if he would come to the police department or if he preferred, I could come to his place of employment. Ingerson stated that I was welcome to go there.

I met with Ingerson on his property approximately a half hour later. I advised Ingerson I was there to speak to him about an encounter he had with Swan in the parking lot of Shaw's Supermarket. I told Ingerson that Swan had made a video of the encounter. I explained to Ingerson what I observed in the video that Swan took. I advised Ingerson that I watched him drive by Swan and say something to the effect of, "Your day is coming." I explained to Ingerson that Swan alleged he could see Ingerson run his finger across his throat.

I asked Ingerson if he made that statement. Ingerson admitted that he did. I also asked Ingerson if he made a motion with his finger. Ingerson also admitted that he did that too. Ingerson advised me that this has been all about the Casella Landfill and his application with the State of New Hampshire to obtain permitting for a new landfill on his property. Ingerson explained to me that Swan and his group is opposed to the landfill and has been fighting him every step of the way.

I asked Ingerson the purpose of the statement and the hand motion. Ingerson told me that he was sick of Swan and his attacks. Ingerson stated that Swan flies drones over his property recording activities. He stated that he believes Swan has even flown the drone over his residence. Ingerson stated that he knows that this has been done because the property videos have been posted online.

Ingerson told me about an instance time when Swan verbally accosted him and his girlfriend at the store accusing them of ruining the environment and other things. Ingerson stated that there was another time when his girlfriend was verbally confronted by Swan.

Ingerson also told me there have been vulgar videos and pictures posted online by Swan. Ingerson said that he is at the end of his rope concerning this situation. Ingerson said he is trying

to run a business and Swan's actions are affecting him and his business negatively. Ingerson stated that he has a box of documentation where Swan has done these things against Ingerson. Ingerson stated that he has been removed from town boards because of Swan.

I returned to the subject of the threat. Ingerson said he did it, but did not mean it seriously. He said it was probably not the right thing to do, but every time he turns around there is some other action, or statement that Swan is making against him. He complained that Swan has been on his property and was told by other officers that he could not serve Swan with a no trespass order.

I advised Ingerson that he should not go near Swan now or in the near future. I explained that he should not send him messages or call him. I explained that the case was going to be investigated and that there was a possibility of a Criminal Threatening charge. Ingerson told me that he was not worried and that he was provoked by Swan and is continually being provoked.

On March 15, 2021 at approximately 9:00AM, I received a forwarded email from Ofc. Donahue regarding the case involving,

Swan, Jon

and

Ingerson, Douglas

Ofc. Donahue sent me an email he received from Swan on March 12, 2021. In the email, Swan was bringing this email to show his concerns for his personal safety. Included in that email was a Facebook post on the Facebook group, "North Country Trash Talk". Swan perceived some of these messages as being threatening.

In my review of the messages, they are out of the Littleton jurisdiction. None of the messages have Ingerson mentioned in them, Ingerson was not the author of the messages nor do they appear to be related to the case at hand. A copy of the email from Swan and the Facebook group messages as I received them is included in the case investigation file.

Swan, Jon

To set up a second interview with him regarding his complaint of Criminal Threatening against,

Ingerson, Douglas

Swan agreed to meet with me at the Littleton Police Department later that morning.

In our meeting Swan informed me that he wished to move forward with this case investigation. He also told me that this was all over the potential development of Ingerson's property for the purposes of a landfill.

I explained to Swan that I had interviewed Ingerson and that he had been truthful as to what occurred. I explained to him that Ingerson admitted that he stated, "Your day is coming." and that he ran his finger across the area of his neck and shoulders.

I stated to Swan that Ingerson reported that he had multiple negative interactions with Swan. These included the contacts in public, the flying of drones over his property and residence, and coming onto Ingerson's property without permission. Swan stated to me that he has never been on Ingerson's property and the contacts in the public were him questioning either Ingerson or his girlfriend. When questioned about the drone fly overs, Swan told me that he did not have a drone license and that he did not fly any drones over Ingerson's property.

I explained to Swan that I believed Ingerson threatened him and provided Swan with the Criminal Threatening RSA. Additionally, I explained to Swan that I did not want to make this case about the landfill, nor did I want it to play out in the court as such should Ingerson be charged.

Swan and I spoke about the case more and I advised him to stay away from Ingerson and not to go on his property. I also asked him to refrain from posting anything about this until the investigation was complete. Swan stated that he would.

On February 28, 2021, at approximately 1:26pm, I met with,

JON SWAN,

at the Littleton Police Department. JON informed me he had been having issues with an individual named,

DOUGLAS INGERSON.

JON told me approximately a year ago he had been crossing Main Street, on the cross-walk near Topic of the Town when DOUGLAS dropped the snowplow on his truck in the street, startling JON. JON said he also observed DOUGLAS mouth something to the effect of, "I'm going to kill you," or "I'm going to get you." JON said he was reporting this incident to have it documented. I observed from our records that JON had reported this on March 3, 2020.

JON told me earlier that day, at approximately 1:30pm, he observed DOUGLAS following his vehicle on his way to Shaw's. JON advised he started recording on his phone while he was parking in the turning lane on Meadow Street into the Shaw's/Walmart entrance, in case DOUGLAS did something. JON told me approximately 30 seconds later, DOUGLAS drove by JON, coming into JON's lane, almost side-swiping his vehicle.

JON said he pulled into the Shaw's parking lot and observed DOUGLAS come from behind Shaw's, utilizing the entrance further down on Meadow Street. JON said DOUGLAS pulled his truck in the lot directly across from him. JON exited his vehicle and continued to record in case something else occurred. JON said DOUGLAS approached him, driving the truck. JON felt DOUGLAS was going to hit him so he stopped near a vehicle. JON said DOUGLAS stopped and told him, "Your day is coming," and then DOUGLAS made a gesture by running his finger across his throat horizontally. I am aware that this gesture is often used to signal someone's throat being cut, or someone being killed. JON informed me he felt it was a menacing threat. JON advised me DOUGLAS then exited the parking lot.

JON informed me he would fill out a written statement online and provide me the video footage he had captured with his phone. JON provided the statement a short time later and informed me he could not email me the video as the files were too large. JON provided the following links to the videos where he had uploaded them to YouTube under an unlisted section:

The first video started inside JON's vehicle as he is passing by McDonald's on Meadow Street. JON states on the video, "I got INGERSON behind me so that's why I'm recording this." As JON moves over to the turning lane into Shaw's/Walmart JON said, "Looks like he's gonna pass me." As the truck passes JON, JON stated, "Boy he cut it close. You see that?" The recording then ends.

The second video started while JON was still inside his vehicle. JON had placed the phone in his chest pocket. JON says, "INGERSON's right over there." JON exited his vehicle, which was facing the right side of the store, and walked to the front passenger's door. JON then walked towards the store. As JON was walking, a black truck drove by slowly and a male voice can be heard saying, "Your day is coming." The truck then turns left driving in front of the store. The truck was a large dark colored truck with a dump style body. The sides of the dump bed had large metal screening on either side. JON then retrieved the phone from his pocket and stopped the recording.

On March 15, 2021, Inv. Cox spoke with JON. JON informed Inv. Cox he had gone up to DOUGLAS and his girlfriend to question them. JON stated he did not have a drone license and did not fly a drone over DOUGLAS' property. In reviewing the links to the Save Forest Lake YouTube channel, I observed many videos involving drone flyovers. The videos did not show where the drone came from or who was operating it.

Statement of Jon Swan

Thank you for taking the time to speak with me about this incident that occurred today, Feb 28, 2021 beginning at 1:01 PM in Littleton, NH. As you can see from the 2 videos, links below, I was able to document what occurred. Please keep in mind, this is a part of the Forest Lake landfill development that has been very heated and controversial as Mr. Ingerson is the selling landowner to the landfill company, Casella Waste Systems of Rutland, VT. There is a lot of money at stake for both parties, just as there is much at stake for those of us who oppose it as we will be negatively impacted should this development be permitted to exist. I've had numerous people tell me they would not be surprised to see me turn up dead someday. I have had to grow eyes in the back of my head which is why I noticed Mr. Ingerson's black GMC dump truck behind me in traffic and he obviously knows what my burnt-orange Jeep Wrangler looks like, so I was not surprised to see him following me.

As I stated to you in conversation, I had stopped by the Littleton PD last year following an incident where Mr. Ingerson threatened me as I was crossing the street to get to the Topic of the Town restaurant to join my wife for breakfast. I did ask the police officer I spoke with to document my visit then, so as to have it on the record. As I told her, I was in the crosswalk when the truck that had stopped on my left slammed his snow plow very hard to the ground, startling me. Then, the driver proceeded to drive forward and that is when I saw Douglas Ingerson, Jr. mouth the words "I'm going to kill you" or "I'm going to get you" while being very angry in animated fashion as he drove thru the crosswalk. I felt this important to document, and it was there that I also learned that there were no street cameras downtown, which I had hoped would have caught the confrontation on video.

Fast forward to today, in the first video, I began to record as I was awaiting to turn left into the Shaw's parking lot at 625 Meadow Street in Littleton. At :36 seconds into the video, you can see Mr. Ingerson's black GMC dump truck pass me by, he had come over into my lane and I really thought he was going to side-swipe me.

But that was not the last of the encounter with Douglas Ingerson, Jr. for today.

In the second video, shot in Shaw's parking lot minutes later, you will see that Mr. Ingerson had obviously driven to the second Shaw's entrance, behind the store, turning left to enter the parking lot and pull up and park in the lot across from me, next to a red car, as you will see at :15 seconds into the video. In other words, he circled back to interact with me in some form or fashion. I had put my cell phone in my shirt pocket to hopefully capture anything Mr. Ingerson said or did in the same fashion as a body cam. At 1:02 in the video, I proceeded to stop at the grey car so as to allow Mr. Ingerson to drive by without the opportunity to run me over. You can hear his truck approaching at that point. At 1:06 he states "Your day is coming". We were looking at each other and in his mirror, he ran his finger across his throat and smiled. I certainly perceive that as a menacing threat. He then exited the parking lot and I proceeded to buy the items I needed and then drove to your department to file charges. I do not know if this is menacing or harassment, but I do feel that once again, I was threatened by this same person, as reported before. He followed me and sought me out and I would like to press charges.

Jon came to the PD to advise of an incident which occurred on Sunday. The following is what Jon alleged happened:
Dear Littleton PD:

I would like to document the following incident that happened this morning in downtown Littleton around 11:15 am this morning, While waiting for our breakfast at the Topic of the Town diner, I had noticed that I had left my tupperware leftover container in our car parked behind Jax Theatre in the public parking lot. Being that we are in the midst of a fight to stop a landfill in Dalton, NH, I am very sensitive to trash and I knew we would have leftovers. I went to the car to retrieve my container and was crossing the public crosswalk in front of Jax theatre when I encountered Douglas Ingerson, Jr. of 104 Douglas Drive in Dalton as the driver of the stopped vehicle on my left, allowing me to cross. It was a black dumptruck with a worn silver plow on the front. I could not see nor did not notice the driver as I crossed until I was nearly midway thru the walk when I noticed the truck rolling slowly forward and heard a LOUD clang as the plow was slammed to the blacktop. I then turned to look in that direction, to my left, as the truck was proceeding forward and I saw the driver, who was Douglas Ingerson, Jr. He was obviously yelling at me in his cab, but I could not hear the words but could read his lips and thought I could see him mouthing the words "I'll hit you next time" or "I'll kill you next time". Regardless, he was extremely angry and agitated. Frankly, I was not in fear of my life as I was past his truck and if he had truly meant me harm, he could have done so while I was unaware of his presence in the crosswalk. The "next time" could certainly play out differently as he could have very easily run me down in the crosswalk. I do tend to look over my shoulder frequently while out and about as I know I am a target to some people out there.

Being as we are opponents in the fight over the proposed landfill development, this is not the first time I have encountered an angry Mr. Ingerson. There is a lot of money at stake as he is the owner of the land in Dalton, next to Forest Lake State Park, who is under contract with Casella Waste Systems to sell his land to them for a large landfill development. I am one of those joined together in the fight to oppose this landfill development. I have also taken a more active role in Dalton politics and there, too, our interests conflict. I just want this on the record as it just happened today.

Previous encounters to note: this summer, while I was in downtown Littleton for a political appearance at the Opera House, Mr. Ingerson and his girlfriend, Vanessa Hines Cardillo, drove by me in her red BMW while I was standing outside and they both flipped me off. No big deal and I do not respond to such behavior. They have also flipped me off in passing at the Dalton Town offices. Again, no reaction given as I do not care for confrontations and escalations as we are adults and I have no desire to get into physical altercations.

Oddly enough, while I was at the Dalton Transfer Station yesterday, a neighbor of mine, whom I do not really want to identify as I am not filing any complaints or charges, informed me and my wife that during the past summer/fall, while he was at the Littleton WalMart, he overheard one of Mr. Ingerson's sons telling someone in the aisle nearby that they would like to bury me and me Jeep in Forest Lake. Frankly, my neighbor was very disturbed and concerned over the severity of the statement. That was the first I'd heard of it.

I certainly see this incident today as a threat, but I do not wish to file any reports, only to note the incident(s) for posterity's sake and for documentation's sake that this incident took place should something more drastic occur in the future. Things will continue to be heated as the fight to save Forest Lake continues. It's estimated to be worth millions of dollars to Mr. Ingerson and billions to Casella Waste Systems.

I will add, that several friends of my wife have stated in conversations with my wife their belief that I will likely be murdered at some point due to my very public opposition to this proposed development and the nature of the players involved.

Again, to reiterate, this is solely meant to record for my records as well as yours or others should something happen to me in the future relative to this landfill development.
