Dear Mr. Swan:

We represent Casella Waste Systems, Inc. If you have retained counsel, please forward this letter to him or her.

It has come to our attention that you have continued to defame our client despite being on notice of the defamation action we have commenced against you. We have also learned that you have been reposting false allegations that reporters and others have made about the company in an apparent effort to justify your own defamatory statements as founded.

This letter notifies you that defamatory statements you make after you have been sued for defamation provide additional grounds for your liability and exacerbate the damages you have caused. You should also be aware that republishing defamatory statements made by others is itself defamatory.

If you have not yet consulted with a lawyer I urge you to do so immediately so that you understand the legal implications of your current course of action. In the meantime, we demand that you desist from publishing or republishing defamatory statements about our client.
